TECHNICAL TERMS AND CONDITIONS

- 1. LAN maintenance should be for a period of one year extendable to another one year subject to satisfactory performance.
- 2. The service provider will maintain records of the complaints received, calls attended and closing of calls and submit the report to IT Division, CSIR Cx at the end of every calendar month for verification.
- 3. The service provider would proactively initiate necessary action for smooth operations of LAN infrastructure at CSIR Cx.
- 4. The service provider would bring all the necessary tools and expertise for the maintenance work.
- 5. The cabling would be labelled as per the IT Divisions, CSIR Cx schemes defined schedules.
- 6. The nodes would be tested using standard penta scanner testing and reports should be submitted to IT Division, CSIR Cx for verification.
- 7. The onsite maintenance support staff should have their own/vendor vehicle and mobile phone to facilitate them at work place. All the charges towards fuel, maintenance of vehicle and mobile phones/call charges shall be borne by the vendor.
- 8. Annual maintenance contract will be comprehensive and will cover all LAN components/switches/cables/conduits/connectors/power adaptors/patch cords/ I/O ports and supports etc.
- 9. All the complaints should be attended immediately. If any of the complaint/ problem could not be solved within one working day then suitable standby replacement of defective LAN component etc: will have to be provided by the contractor at no extra cost and the problem should be solved as early as possible.
- 10. Availability of Network connectivity at each client computer has to be ensured by the vendor, which may include repair/replacement of LAN Cables (structured/ loose cables)/connectors/patch cords etc at vendor's cost.
- 11. The contractor should carry out preventive maintenance during the last month of each quarter, otherwise the bill for that quarter shall not be cleared.
- 12. Replacement of parts/equipment/switches should preferably be of the same model, make and capacity or better and the cost of replacement will be borne by the contractor.
- 13. The contractor should have CNE's, MCSEs, or other Certified Engineers on his rolls to take care of network and provide satisfactory solution on the spot. Contractor has to provide one resident engineer on all working days from 9.00 AM to 5.30 PM at contractor's cost In case of official meetings on holidays, the resident engineer may be asked to be present in office to take care of the network problems at his own cost. No vehicle or additional payment will be given by CSIR (Cx) for the same.
- 14. The comprehensive Maintenance includes replacement (if required) of patch cords, cascading cords (structured/ loosely hanging cables) at contractor's cost, using standard CAT5/CA T6 cable. In case of any fault, replacement & installation of PVC conduit/batten or flexible pipe etc for the existing structured cabling, has to be done by the contactor at his own cost.
- 15. For properly fixing of loosely hanging UTP cables, jobs may be assigned by HRDG, CSIR(Cx) to the contractor from time to time. This newly laid cabling will automatically become part of existing LAN and has to be maintained by the contractor for the remaining duration of the contract, at no extra cost to HRDG, CSIR(Cx)
- 16. Contractor should provide the Certificate from at least three different organizations out of which at least one from Govt. Organization, for carrying out the similar type of CAMC at those organizations satisfactorily.
- 17. Rates must be quoted FOR basis and must be valid for a period of three months from the date of closing of the tender.

- 18. Payment shall be made to the contractor after completion of each quarter. Contractor has to provide the bill duly signed by Head IT or his deputy as the case may be for release of payment.
- 19. Head, HRDG, CSIR Cx, New Delhi-12 reserves the right to delete any items or accept the higher bid at his own discretion who doesn't bind himself to accept lowest quotation or in part, without assigning any reason.
- 20. All faulty items, which are replaced, are property of CSIR and are to be returned to CSIR (Cx) Stores.
- 21. Rates for supply and installation of passive LAN Components may be quoted for the items as per Annexure-A. CSIR (x) may sign a rate contract with the vender for the items specified in Annexure.
- 22. CSIR (Cx) reserves the right to award only the AMC contract without signing any rate contract for items mentioned in Annexure-A.

GENERAL TERMS AND CONDITIONS

1 Submission of Quotations: The quotations shall be submitted addressed to the Head, HRDG, Council of Scientific and Industrial Research Complex, Library Avenue, Pusa, New Delhi-110012. The envelope should be super scribed with tender number, due date and time, date and time of opening. The bids will be opened first on the prescribed date and time in the presence of representatives of the vendors who wish to be present at that time. The bids will be opened even if the representatives of the firms are not present. In case, the Tender Opening date is declared a holiday, the tender would be opened on the next working day at the prescribed time.

<u>2 BID: MUST CONTAIN THE FOLLOWING DOCUMENTS:</u>

(a) Detailed specifications of quoted services/products.

(b) Compliance Statement duly filled the' parameters of quoted specifications against each parameter of CSIR specifications and deviation, if any, in the specification of product/service as per Annexure 1.

(c) Copy of VAT/TIN, PAN and Service Tax Registration Certificates.

(d) Client List : List of reputed clients/ Organization of Central Government PSU's/ Autonomous Bodies/ CSIR or any of its Constituent Lab/Institute along with the copies of the order to whom Network maintenance services etc have. been provided during last two years and which can be verified by CSIR, if required

(g) Earnest Money Deposit of Rs. 5000/- in the form of Demand Draft or FDR pledged in favour of Head, HRDG, CSIR Cx, New Delhi or unconditional Bank Guarantee (as per Proforma enclosed) in favour of Head, HRDG, Council of Scientific and Industrial Research Complex, Library Avenue, Pusa, New Delhi-llOOl2 valid for a period upto 45 days beyond the bid validity period (i.e. valid for 135 days from the date of opening of tenders).

(h) This Tender Document shall be returned along with the bid, with each page thereof duly signed by the bidder and affixed with the seal of the company, without which the tender would be rejected.

(i) A certificate that schedule of requirement and all the terms and conditions (Technical as per Annexure II and General Terms and conditions as per Annexure III) as mentioned in the Tender Inquiry letter, have been read carefully and fully understood and are acceptable to you for entering into the contract.

(j) A Certificate shall be furnished by the bidder along with the bid that all costs of support staff for repair and maintenance charges have been included in Bid.

<u>3. BID:</u>

Your quotation must be in accordance with the Proforma (Annexure IV) for quoting the prices.

4. <u>Submission and opening of Tenders</u>

4.1 (a) Last Date and time for submission of Quotation: up to 02:30 P.M. on 27th Aug., 2013.

4.2 (b) Date and Time of Opening of Bid: at 03:00 PM on 27th August, 2013.

5. <u>Validity of the quotation</u>: The quotation must be valid for ninety days from the date of opening of the Bid. In case the validity of the quotations expires due to Technical/Administrative reasons, CSIR Cx reserves the right to request the firms for the extension of validity of the quotations. The Vendor will be at liberty to accept or reject CSIR Cx request, and in case they choose to reject CSIR Cx request, their EMD will not be forfeited. In case the vendors choose to accept CSIR Cx request for extension then validity of the EMD, if expired, shall also be adequately got extended.

6. PRICES:

6.1 The prices must be inclusive of Packing, Forwarding, Freight, Insurance and

installation of all items at different locations of CSIR Cx, New Delhi.

6.2 Please quote .firm and best lowest prices for services/product. Downward revision in the prices during the period of contract will be acceptable and upward revision in the prices will not be acceptable during the period of contract.

6.3 Any discrepancy between quoted prices in figures and in words, if noted, will be sorted out in the following manner;

a. If there is a discrepancy between the unit price and the total price the unit price shall prevail and the total price will be corrected accordingly.

b. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.

c. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to above.

6.4. If there is such discrepancy in a bid, the same is to be conveyed to the bidder and if the bidder does not agree to the observation of the CSIR Cx, the tender is liable to be ignored/rejected.

7. Taxes: The percentage of VAT / Service Tax or any other tax must be quoted in clear terms separately. If the taxes are not mentioned separately, it will be presumed that the rates quoted are inclusive of all taxes.

8. Installation: The installation of the items provided will be

executed in all the respects by the agency to the complete satisfaction of IT Division, CSIR Cx.

9. Bid Evaluation: The conditional tenders will not be accepted. The Bids will be opened first and analyzed for acceptability. The evaluation of the tenders will be done in a Scientific and logical manner. The Bidders are required to submit their quotation in accordance with the CSIR Cx requirements and specifications.

In case, certain details are missing in the quotation, which do not have appreciable bearing on the quoted prices, CSIR Cx reserves the right to take clarifications along with necessary documents for the same to find out technically suitable tenderer.

The comparison will be made on overall prices for the items which are to be executed and the order will be placed on the lowest quoted firm.

10. Earnest Money Deposit:

10.1 EMD of ` 10000/- in the form of Demand Draft or FDR pledged in favour Head, HRDG, CSIR Cx, New Delhi or unconditional Bank Guarantee in favour of Head, HRDG, Council of Scientific and Industrial Research Complex, Library Avenue, Pusa, New Delhill0012, valid for a period up to 45 days beyond the bid validity period (i.e valid for 135 days from the date of opening of tender)shall be submitted along with the Bid failing which the quotation will be rejected without assigning any reason.

10.2 In case the successful bidder withdraws his offer within the validity of quotation or before entering into the contract within the bid validity period, his EMD will be forfeited. The bidder will have no right to claim for refund of the EMD.

10.3 In case the successful bidder does not honour his commitment within the validity of quotation and back out after placing the order with him, the EMD will be forfeited.

10.4 The EMD if submitted in the form of Demand Draft can be adjusted with the Performance Security if so desire by the successful bidder. If not so, the EMD will be returned to the successful bidder after receipt of Performance Security along with the order acceptance from him.

10.5 The EMD will be returned to the unsuccessful bidders within One month after placing the order with the successful bidder.

10.6 No interest will be paid by CSIR on the EMD amount

11. Performance Security:

11.1 A Performance Bank Guarantee equivalent to 10% of Contract Value in favour of Head, HRDG, Council of Scientific and Industrial Research Complex, Library Avenue, Pusa, New Delhi-ll0012 valid for CAMC period plus 12 months shall be submitted along with the order acceptance by the successful bidder. The same may be got renewed by

successful bidder if the contract extended for next years.

11.2 In case the successful bidder refuse to submit Performance Security, his EMD will be forfeited and the contract will be terminated.

11.3 In case, the Technical Support Services are not rendered by the successful bidder up to the satisfaction of CSIR Cx IT Division and does not improve his technical support services in spite of suitable reminders, the Performance Security will be forfeited without assigning any reason.

12. Delivery: Immediate delivery of the items placed on Rate Contract for passive items of LAN and their installation is needed but in any case not later than 15 days after placing the Purchase Order and the same shall be installed within' 15 days after delivery.

13.1 No advance payment will be made to the contractor. The performance of the contractor will be monitored/assessed by the I.T. Division on quarterly basis. Accordingly the payment will be made on quarterly basis after certification of I.T. Division for satisfactory performance of the services rendered by the contractor for the said quarter and production of Preventive Maintenance Reports. The payment will be made through e-payment mode. Bidders are requested to submit their complete bank details in their offer ... 13.2 The Contractor shall submit his bill along with preventive maintenance reports towards the CAMC Charges on quarterly basis after the end of each quarter. The payment for the same shall be subject to recoveries, if any.

14. Penalty: A complaint need to be attended to immediately and should be set right immediately. For any fault in switch/LAN equipment, the replacement has to be provided immediately so that network is not down for more than four hours. In case network remain down for more than four hours, a penalty of ~ 1000.00 per day would be imposed till the fault is rectified.

15. Fall Clause: In case it is found during the period of Contract with CSIR Cx that the successful bidder has concluded a contract for CAMC under the contract conditions similar to CSIR Cx Contract at a price lower than the CSIR Cx price, the contract price will be automatically reduced from that date for the remaining period of contract.

16. Verification: Verification of documents submitted by vendor along with Bid would be carried out by CSIR Cx, if required.

17.
