Sir.

CSIR is interested to enter into Rate Contract for the purchase of Microsoft Products as per Annexure 'B' on Academic License Prices with Software Assurance Option. The sealed tenders are invited from the Microsoft authorized venders. If you are a authorized Microsoft vender/supplier, please submit your quotation offering academic license prices with Software Assurance option for two years for entering into the rate contract for the supply and installation/training of Microsoft products/software's in accordance with the schedule of requirement, instructions to the tenderers and terms and conditions mentioned in this tender inquiry.

Schedule of Requirement

A list of Microsoft Products as per **Annexure** 'B' is attached herewith. The quantity of the Micro Soft Products to be purchased against Rate Contract is not fixed. The procurement of the Micro Soft Products will depend on the requirement of CSIR and it's Laboratories **Annexure-A**. CSIR and it's laboratories reserve the right not to buy any products contained in the Rate Contract, if the requirement does not exist.

Instructions to Tenderers

The under mentioned documents must be attached along with the quotation failing which CSIR shall have the discretion to reject the quotation or call the firm to submit the required documents. In case the firm does not provide the required documents even after giving an opportunity to submit the same, the quotation will be rejected without assigning any reason.

- 1. The current authorization certificate of M/s. Microsoft Corporation (India) Pvt. Ltd., in original in favour of bidder, in reference to this tender inquiry for submission of quotation and entering into rate contract, on behalf of Microsoft, failing which the quotation will be rejected without assigning any reason. The quoted prices should also be certified by Microsoft that the quoted prices are academic license prices.
- 2. The detail write up indicating technical expertise/skills and resources in respect of Microsoft products and the number of qualified software engineers employed and including the support staff.
- 3. List of Govt. Organizations/CSIR and its Laboratories to whom the Microsoft products were supplied during last Two years. The photo-copies of orders and invoices must be attached along with the quotation.
- 4. Copies of VAT/CST/TIN Registration number and PAN number.
- 5. Performance certificate in favour of tenderer issued by Govt. Organizations/CSIR and its laboratories regarding timely execution of orders with installation and training and providing satisfactory services during warranty period.
- 6. A Certificate to the effect that all the CSIR terms and conditions of this tender are acceptable to the tenderer.
- 7. A check list **Annexure-E** duly filled and signed.

Terms and conditions:-

1. Submission of quotations

- 1.1 The tender should be kept in sealed envelope, addressed to the Joint Secretary(Admn.), CSIR superscribing the tender number, subject, due date & time and date & time of opening of the bid. This envelope should be dropped personally in the tender box kept at CSIR reception.
- 1.2 In case tenderer opt to submit his quotation by normal post/Registered Post/Speed Post/Courier, the quotation must reach to this office before prescribed date and time failing which the tenders will not be considered. If the, tender is delivered at CSIR after the prescribed date and time by the respective agency, CSIR will not be responsible for any transit delay on the part of concerned agency.
- 1.3 Quotation submitted by FAX/E-Mail will not be considered.
- 1.4 The priceses should be quoted for single user academic licenses and for multiuser academic licenses separately.
- 1.5 The documents as required in this tender document, must be submitted along with the quotation.

2. Receiving and Opening of Tenders

- 2.1 The quotations should be submitted on or before **7-11-2008** by **3:30 P.M.**
- 2.2 Date and Time of opening of quotations at 4: 00 P.M on 7-11-2008.

3. **Opening of Tender**

- 3.1 The quotations will be opened on the prescribed date and time in the presence of representatives of the vendors who wish to be present at that time. In case, the Tender Opening date is declared a holiday, the tender would be opened on the next working day at the prescribed time.
- 3.1 Late/delayed tenders will not be opened.

4. <u>Late/Delayed Tenders</u>

4.1 The tenders which will be received at CSIR after the prescribed date and time, such tenders will be treated as late/delayed tenders. The same will not be considered at all and will be returned to the concerned firm in unopened condition.

5. **Evaluation of Tenders**

5.1 The evaluation of tenders will be done in a scientific and logical manner. If needed, the firms may be called for technical discussion and clarifications. The firms representative should be technically qualified and sound to clarify technical aspects and competent to confirm the desired clarifications in writing and submit the desired documents on the spot. Only those firms, which qualify technically and in accordance with the terms and conditions of this tender, will be considered for comparison and the rate contract will be awarded as per Clause No.21 of the terms and conditions.

6. **Price**

- 6.1 Price should be F.O.R. CSIR Headquarters, Anusandhan Bhawan, 2 Rafi Marg, NewDelhi-110001 and all CSIR Laboratories and institutes (situated across the country as per the address list provided at Annexure-A). No delivery charges shall be payable.
- 6.2 Any discrepancy between the quoted prices in figures and that of in words, if noted, will be sorted out in the following manner:-
 - (a) If there is a discrepancy between the unit price and the total price the unit price shall prevail and the total price will be corrected accordingly.
 - (b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
 - (c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to above.

7. **Validity of Quotation**

7.1 The quotation must be valid for a minimum period of six months from the date of opening of quotations. CSIR reserves the right to request the firms for extension of validity of the quotations. The vendor will be at liberty to accept or reject CSIR request.

8. **Taxes**

8.1 All the quotations should clearly indicate the percentage of taxes and duties applicable, if any. Vague terms like at actual or as applicable shall not be quoted. Such terms create confusion in making comparison. If the percentage of tax and duties is not mentioned in clear terms separately, it will be presumed that the rates quoted are inclusive of applicable taxes and duties and no request or correspondence will be entertained at a later stage. If the taxes and duties are claimed at later stage after awarding the contract, the contract will be cancelled and the EMD will be forfeited.

9. Earnest Money Deposit

- 9.1 An EMD of Rs. 2.00 lakh in the form of Demand Draft or Bank Guarantee in favour of Joint Secretary (Admn.), CSIR will be submitted by the tenderer along with the quotation which will be valid for a period of 06 months from the date of quotation, failing which the quotation will not be considered. Bank Gurantee Performa for Earnest Money is enclosed at Annexure `C'.
- 9.2 In case the tenderer withdraw his quotation after its opening and within the validity of quotation, the EMD will be forfeited without assigning of any reason.
- 9.3 The EMD of unsuccessful tenderers will be returned to them within 30 days after entering into the rate contract with successful tenderer. The EMD of successful tenderer will be retained for the period of contract plus two months. In case of default to fulfill the contractual obligations by successful tenderer, the EMD will be foreited.

10. Performance Security

10.1 The successful firm shall be required to submit the performance security along with the acceptance of order, in favour of CSIR/its Lab in the form of Demand Draft or Performance Bank Guarantee valid for 14 months, equivalent to 10% of order value against the purchase orders to be placed by CSIR or its laboratories under rate contract. Bank Gurantee Proforma for Performance Security is enclosed at Annexure `D. The Performance Security will be forfeited with out assigning any reason if the successful tenderer fails to execute the work.

10.2 CSIR and its Laboratories is not liable to pay any interest on the deposits towards EMD and performance Security in any circumstances.

11. **Delivery**

11.1 Supply will be made within 30 days after receipt of confirmed Purchase Order from CSIR and it's Laboratories

12 Warranty

12.1 2 Years for the software media(CD) from the date of supply. In case the media is corrupted or damaged during the warranty period, the same will be replaced free of cost.

13. <u>Software Assurance Option</u>

- 13.1 All Microsoft Products/Softwares indicated in the Annexure 'B' should be with Software Assurance(SA) option. CSIR and it's Laboratories should be supplied upgraded version of the software free of charge for two years from the date of satisfactory installation.
- 13.2 The items/software to be supplied should be latest upgraded version under SA Option and of good quality and standard as per Microsoft specifications.

14 Fall Clause

14.1 The Academic License Prices of softwares should be the best lowest academic software license prices. The Firm will not supply similar software which are in purview of Rate Contract to any organization at a price lesser than the CSIR RC prices on terms and conditions of sale similar to the CSIR Rate Contract. In case Microsoft or it's any authorized business partner supply the given software in Annexure-'B' at a price lesser than the CSIR Rate contract prices during the period of Rate Contract, the firm will pass on the benefit to CSIR and it's Laboratories. Further, if the agreed Academic License Prices of the given softwares as per Annexure B under the Rate Contract, are reduced by Microsoft during the period of Rate Contract, the reduced prices will be intimated to CSIR and it's Laboratories and the same will be charged accordingly by the firm.

15.1 The 100% payment will be made by CSIR/its Laboratories after satisfactory installation and training on the supplied softwares.

15.2 Payment should be claimed through pre-receipted bills drawn in triplicate, original copy being signed over a revenue stamp. The payment will be made through A/C payee cheque or Electronic Mode.

16. Installation

16.1 The installation of the supplied softwares shall be done by the firm free of cost within 02 weeks from the date of supply failing which penalty as per para-20 below shall be leviable.

17. **Training**

17.1 If needed, training will be provided free of charge by the rate contract holder in connection with the supplied Microsoft products/software to the satisfaction of CSIR/its Laboratories.

18. Rejection/Acceptance of items

- 18.1 CSIR and it's Laboratories reserve the right to reject the items/software, if found unsuitable and not conforming to the approved specifications. The rejected items, if any, shall have to be taken back and the same will be replaced by good quality, latest upgraded softwares forthwith at the suppliers cost and no payment will be made for the rejected items. The supplied items/software will be inspected and if the same are found in satisfactory working condition and installed upto the satisfaction of users then only the same will be accepted by CSIR/its Laboratories.
- 18.2 The software packages to be offered should be legally valid, licensed and latest version along with the complete set of Media and manuals. All software should fully meet the copyright/Intellectual Property Rights Regulations. If any particular software does not match with the approved specifications or is found inferior in quality or not legally valid, licensed and latest version, the same is liable to be rejected out rightly. No payment will be made on such rejected supply and such items will have to be taken back by the supplier at his own cost.

19. **Media**

Documentation which is a part of the media, shall be supplied as soft copy also along with the main software CD and license.

20. Penalty

20.1 For delay in supply and installation beyond the prescribed period, penalty of 0.1% per day of order value subject to a maximum of 10% of order value would be imposed. The same will be charged by the CSIR and its Laboratories directly towards delayed supplies against specific purchase orders.

21. Conclusion of RC

21.1 CSIR reserves the right to conclude RC with single lowest firm or conclude parallel RC with more than one firm. In case CSIR wishes to conclude parallel

RC, the technically qualified firms quoted L2, L3, L4, L5 etc. shall be required to match their prices with the lowest quoted firm. The parallel RC will be awarded to those bidders who shall agree to match their prices with the L1 prices.

- 21.2 In case parallel rate contract is awarded to different technically qualified firms, CSIR and its Laboratories at then discretion may buy their requirement of microsoft products/softwares under the rate contract from any of the rate contract holders. No rate contract holder shall have any claim for placement of order to him for the procurement of microsoft products/software under the rate contract.
- **21.3** CSIR/its Laboratories reserves the right to change the order, quantity or not to buy any microsoft products/software specified in the rate contract.

22. Arbitration

22.1 If at any time there shall arise any dispute, doubt, difference or question with regard to the interpretation or meaning of any terms and conditions, prices, etc. of this Rate Contract or in respect of the rights, duties and liabilities of the parties hereto or in any way touching or arising out of these presents or otherwise in relation to the present Rate Contract, then every such dispute, difference, doubt or question (except the decision whereof is herein expressly provided for) shall be referred to the arbitration of the sole arbitrator to be appointed by the Director General, CSIR under the Indian Arbitration & Conciliation Act, 1996 or any statutory modification re-enactments thereof and rules made there under for the time being in force shall apply to such arbitration. The venue of arbitration shall be the place from where the contract is finalized.

23. Rejection of tender

Failure to comply with all the terms and conditions mentioned herein would result in the tender being summarily rejected.

24. The Joint Secretary (Admn.), CSIR reserves the right to reject or accept any or all the quotations or terminate the rate contract at any time without assigning any reason.
