Sealed tenders are invited from Hp authorized distributors/ Channel Partners/ resellers who are authorized by HP to supply HP printer Cartridges/ink Cartridge.to award a rate contract for a period of one year for the supply of HP printer toner/ink cartridges for various types of laser printers and inkjet /Desk jet printer as per schedule of requirement Annexure- "A".

Terms and conditions:-

- The current HP authorization certificate in original in reference to this tender must be submitted by the bidder along with the quotation failing which his quotations will be rejected out rightly without assigning any reason.
- 2. The Bidder should submit valid documentary proof of VAT registration number.
- 3. A certificate that all the terms & conditions of are acceptable to the vender.
- 4. **Submission of quotations:** The quotations shall be submitted under One Bid System addressed to the Joint Secretary(Admn.), Council of Scientific and Industrial Research, 2, Anusandhan Bhawan, 2 Rafi Marg, New Delhi-110001. The Bid should accompany with documents as required at S.No. 1 to 3 this document.

The tender envelope should be sealed & super-scribed with tender number, due date and time, date and time of opening and tender for HP Printer cartridges. The tender will be opened in the presence of representatives of the vendors who wish to be present at that time. In case, the Tender Opening date is declared a holiday, the tender would be opened on the next working day at the prescribed time.

5. Receiving and Opening of Tenders:-

- 5.1 Last date and time for submission of quotation: Upto **3:30 PM on 30 January 2009**
- 5.2 Date and Time of opening of Technical Bid: at **4:00 PM** on **30**January **2009**

6. Prices:-

- 6.1 Prices should be Free delivery at CSIR Headquarters, Anusandhan Bhawan, 2 Rafi Marg, New Delhi-110001
- 6.2 Any discrepancy between quoted prices in figures and that in words, if noted, will be sorted out in the following manner:-
 - (a) If there is a discrepancy between the unit price and the total price the unit price shall prevail and the total price will be corrected accordingly.
 - (b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
 - © If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to above.

7. Validity of Quotation:-

The quotation must be valid for minimum 90 days from the date of opening of quotations. CSIR reserves the right to request the firms for the extension of the validity of the quotations. The vendor will be at liberty to accept or reject CSIR request.

- **8. Warranty**:- As per the norms prescribed by HP India Ltd for each product.
- **9. Taxes**:- The percentage of Tax must be quoted in clear terms separately. If the percentage of taxes are not mentioned separately, it will be presumed that the rates quoted are inclusive of taxes.
- **10. Delivery**: Within one week after the placement of the purchase order against rate contract .
- **11.** The printer cartridge should be delivered in original HP Packing. Any free gifts announced by HP on any cartridge. The same shall be supplied along with the ordered item automatically to CSIR.

12.0 Payment:-

- **12.1** 100% within 30 days after receipt subject to inspection and acceptance of materials in good working condition. No advance payment will be made.
- **12.2** Payment should be claimed through pre-receipted duly affixed with revenue stamp bills in triplicate, original copy being signed over a revenue stamp.
- **13.0 Arbitration:** Except where otherwise provided in the contract, all questions and disputes relating to the meaning of the specification, and instructions herein before mentioned and as to the quality of materials, as to any question, claim, right matter of thing whatsoever, in any way arising out of or relating to the contract, specification, estimates, instruction, order of these conditions or otherwise concerning the works, or the execution of the same whether arising during the process of the work of after the completion or abandonment thereof shall be referred to the sole arbitration of a person nominated by the Director General, Council of Scientific and Industrial Research, New Delhi, and if he is unable or unwilling to act to the sole arbitration of some other person appointed by him unwilling to act as such arbitrator. The submission shall be deemed to the submission to arbitrator under the meaning of the Arbitration & Reconciliation Act, 1996 or any satisfactory modification of enactment thereof for the time being in force, conclusive and binding on all parties of the contract.
