Empanelment of Exhibition Agencies for Exhibition Related Work

CSIR is one of the largest publicly funded organizations in the world. It has a network of 37 laboratories and their field centers spread across the country. True to its spirit, CSIR has been making extensive efforts to ensure appropriate utilization of its technologies and products for the welfare of common people. In this regard, CSIR regularly participates in several national and international exhibitions and some time at a very short notice. CSIR wants to empanel five specialized exhibition agencies for help in the preparation of exhibition material in the form of different kinds of posters by way of digital printing, backdrops, murals, dioramas, models etc., and execution of other exhibition related work including fabrication of CSIR pavilion and provision of related logistics; supply of specialized display equipment of international standards etc.

Eligibility Criteria

1. This invitation for bids is open for exhibition agencies only (Advertising agencies need not apply).

- 2. A minimum of five outstanding exhibition jobs undertaken during the last three years, each exceeding the value of rupees five lakes alongwith documentary evidence.
- 3. Annual turnover of minimum of rupees 50 lakh for exhibition related jobs during the last three financial years i.e. 2004-2005, 2005-2006, 2006-2007 (the turnover is to be supported by balance sheets of accounts, duly certified by the chartered Accountant).

- 4. Bid security The bidder shall furnish, as part of its technical bid, a bid security (EMD) for an amount of Rs. 50,000/- (Rupees Fifty Thousand only) by Demand Draft/Pay order drawn in favor of Joint Secretary (Admn.) CSIR and payable at New Delhi, as specified in the Invitation for Bids.
- 5. The bidder shall have relevant infrastructure in-house, including design studio, modules of fabrication structure of reputed make sufficient enough for built up space area of minimum of 1000 sq.m. and digital printing facilities. This would be subject to inspection by the CSIR.

Methodology for empanelling the exhibition agencies

- 1. "Technical Bids" submitted by agencies would be examined by the special committee established by CSIR, and the committee will shortlist the agencies on the basis of technical evaluation of the condition mentioned in the eligibility criteria.
- 2. "Financial Bids" will be opened only of those agencies who will be shortlisted by the committee found responsive. The shortlisted agencies will be informed date and time of opening of the financial bids. The participating agencies may like to send their representatives to be present at the time of opening of Financial Bids.
- 3. There are two types of pavilion mentioned in the Tender specifications. One is "Normal Pavilion" and second "Designer Pavilion"

There are nine (1-ix) items in Normal pavilion and all the agencies have to mandaterily quote their rates for all (1-ix) items, keeping in view all the elements and provisions of services specified in Annexure-I. The agencies who have not quoted for all the nine items shall be summarily rejected.

4. The lowest rate of each of the nine items in Normal Pavilion will be counter offered to all the responding agencies. The agencies will be finally empanelled only after receiving the acceptance of the price offered by CSIR. The bids of the agencies who have not agreed to the price offered by CSIR shall be summarily ignored and their EMD refunded.

Award Criteria of Jobs to empanelled exhibition agencies

Normal Pavilion:

All the five empanelled agencies will be asked to submit design for a particular event both for the pavilion as also the photo panels. The job of a particular event will be awarded on competitive basis to an empanelled agency whose designs (Normal Pavilion or Panels) would get approved by CSIR, whose decision would be firm and final.

Designer Pavilion:

The designer pavilion would be created in the events of extreme importance/relevance to CSIR for fabricating a showcase, competitive amongst the competing the PSU/MNCs, participating in the same event. In such events, CSIR would hire more space and fabricate a pavilion based on a designer concept using a variety of modular inputs (other than the normal octonorm used for normal stalls) for achieving the desired objectives.

Since each designer pavilion for different themes would be different based on different specifications. These will be fabricated by calling limited tenders from the exhibition agencies already empanelled with CSIR for fabricating normal pavilions.

The job allocation of Designer Pavilion would be made on competitive basis based on the design submitted by the empanelled agencies and also the lowest rate quated by them for each design, as per specification given for the particular events.

<u>Note:</u> Mere empanelment with CSIR would not entitle the agencies the right to get the exhibition related jobs, as all such jobs would be allocated only on competitive basis to an agency whose designs (Normal pavilion/Designer Pavilion or panels) would get approved by CSIR, whose decision would be firm and final.

Submission, Sealing and Marking of Bids

- I. "Technical Bid" must contain the following details:
 - 1.) Documents in support of the bidder being an exhibition agency.
 - 2.) Details of Outstanding jobs 5 (nos.) under take during last three years, each exceeding the value of rupees 5 lakh, along with documentary evidence.
 - 3.) A copy of the balance sheet of the Annual Turnover of the agency for three years i.e. 2004-2005, 2005-2006, 2006-2007 establishing the annual turnover: (The agencies may furnish provisional balance sheet duly certified by CA, for the year 2006-2007, if final balance sheet is not available.
 - 4.) Bid security (EMD) for an amount of Rs. 50,000/- as specified in eligibility criteria.

Late Bids: Any bids received after the dead line for submission of bids as prescribed will be rejected.

Refund of EMD: The EMD deposited by the agencies at the time of empanelment shall be refunded within one month after the expiry of the empanelment period.

Period of Empanelment:

The empanelment of the agencies shall be initially for a period one year. This may be extended for another one year subject to satisfactory performance of the empanelled agencies.

AGREEMENT

The expression "COUNCIL" and "AGENCY" shall include their successors, administrators and lawful assignees wherever the context of the express so requires. WHEREAS the COUNCIL is desirous of giving the work contract to the AGENCY for services in the area of exhibition and digital printing and the Agency has offered to provide such services on the terms and conditions hereinafter stated.

Whereby the parties hereto agree as follows:-

- 1. That the contract shall remain in force for one year, which can be terminated by giving one month notice in writing on either side.
- 2. That the AGENCY shall be responsible for fabrication of stall on hire basis, supply of equipment on hire basis, digital printing and other related jobs for the COUNCIL.
- 3. That the AGENCY shall charge the rates as given in Annexure-I (including elements & services to be provided as a part of CSIR pavilion to be mounted by the agency). The payment would be made after the completion of the event.
- 4. That the AGENCY shall be wholly responsible for compliance of various statues and labour laws. The COUNCIL will not accept any liability on account of loss and damage caused to it, if any, by way of accident or otherwise.
- 5. That the disputes between the parties arising out of this agreement or in relation thereto or regarding the interpretation of this Agreement shall be referred to an arbitrator appointed by the Director-General, CSIR, under the provisions of Indian Arbitration and Conciliation Act, 1996 and the rules made hereunder and any

- modification thereof for the time being in force, shall be deemed to apply to the arbitration proceedings.
- 6. That the award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred to is being transferred or vacating his office or resigning or refusing to work or neglecting his work or being unable to act for any reason whatsoever, the Director-General, CSIR shall appoint another person to act as arbitrator in place of the out-going arbitrator in accordance with the terms of this Agreement and the person so appointed shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.
- 7. That the expression Director-General, CSIR shall mean and include an acting/officiating Director-General, CSIR.
- 8. That the venue of the arbitration shall be at Delhi.
