CSIR is looking for bright and professionally qualified person for the position of Chief Engineer (Unreserved) at its Engineering Service Division (ESD), New Delhi.

The post is in Pay Band: Rs.37400-67000 (PB-4) plus Grade Pay of Rs.8900/- + allowances as per Central Government rules, as made applicable to CSIR.

Essential Qualification, Experience and Age :

The candidate should be a professional Civil Engineer with BE/B.Tech or equivalent in Civil Engg. with 20 years experience or ME/M.Tech. or equivalent with 17 years experience.

He should have a demonstrated ability to effectively manage constructions and maintenance work at various sites.

Upper Age Limit: 50 years as on 29.04.2016 (relaxable in the cases of exceptionally meritorious candidates)

Job requirement/Responsibilities

The Chief Engineer, as Head of the Division, would be responsible for networking the construction activities spread all over the Laboratories/Instts. of CSIR and facilitate construction with cost and time effectiveness. He will be responsible to project annual budgets and guide day-to-day operations of the Division and the man-material-money-management.

The appointment may be made on regular / deputation basis. Appointment on deputation basis will be initially for period of 03 years and terms & conditions of deputation will be regulated under DoPT OM No.6/8/2009-Estt.(Pay II) dated 17.06.2010 as amended from time to time.

Selection Process: The candidates shortlisted by the duly constituted Screening Committee shall be interviewed by a Selection Committee. Merely possessing the prescribed qualification and experience shall not entitle a candidate to be called for interview. For this purpose, the Screening Committee may adopt a higher criteria; such decision of the Committee shall be final. The shortlisted candidates shall be informed of the date, time and venue of interview by post/mail.
