

The promotees will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority.

The pay of above officers will be fixed under the normal rules. However, they will have the option, to be exercised within one month from the date of taking over charge of the promoted post, for fixation of pay in the new post with effect from the date of promotion to the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22, under normal rules. They are entitled for Transfer TA, joining time, joining time pay etc. as per rules.

Further, with reference to NIO letter No. 1/1242/17-NIO dated 17/04/2018, endorsed by Director, NIO on 17/04/2018, the DG, CSIR has been pleased to approve that Sh. N.S.
