Dear Sir/ Madam,

We wish to inform that Error Rectification Module (ERM) has been implemented in the CRA system to facilitate Nodal Offices to rectify the errors related to contribution records processed under NPS.

In this regard, Pension Fund Regulatory and Development Authority (PFRDA) has recently advised that the present option of providing Nodal Office Bank details (where the error rectification funds is to be credited), at the time of executing ERM request should be discontinued and the Nodal Office Bank details should be pre-registered with CRA before execution of ERM request. ERM request can be executed only after 30 days (calendar days) of registration of Bank details in the CRA system.

Accordingly, your office is requested to send physical request along with supporting documents (as per enclosed **Annexure N5**) to CRA at the earliest for updation of Bank details in the CRA system. On receipt of physical request at CRA, the Bank details will be verified and updated in the CRA system.
