Sir,

It is seen that in certain Vigilance cases, investigations are taking long time and not completed before the superannuation of the Officers involved and bringing it to the notice of CVO, CSIR only at the time of seeking Vigilance Clearance for their retirement. Moreover, there is no mechanism in place to monitor and expedite the investigations relating to the officers nearing their superannuation. It is, therefore, necessary to keep watch on such cases so that they reach logical conclusion well before superannuation. Now, CVC has also directed to maintain the list of officers against whom investigations are pending and are going to retire within a one year's time.

In view of the above, it is decided that henceforth biodata of officers be obtained as soon as his/her name surfaces during the investigation. Also, the investigation against officers who are due to retire on their attaining the age of superannuation should be expedited and completed at the earliest.

Accordingly the CSIR Lab./Instt./Units shall maintain following list as per the enclosed proforma :

(i) List of officer against whom complaints/vigilance investigation are pending.

(ii) List of officers who are retiring within one year.

Sr. Controller of Administration /Controller of Administration/ Administrative Officer of all CSIR National laboratory/ Institute shall personally be responsible for monitoring & ensuring completion of the investigations on time. Any deviation in this regard shall be viewed seriously.

Within 15 days, details as per the enclosed performa be sent to Vigilance Division. Thereafter every month within first fortnight the information be sent to Vigilance Division/Admn CSIR.

You are, therefore, requested to kindly bring it to the notice of all concerned officers for information & strict compliance.
