It is clarified that the Central Government Employees posted at Faridabad, Gurgaon, Ghaziabad and Noida are entitled to Transport Allowance at the rates applicable to 'other places' i.e. other than 13 classified cities as per the conditions laid down in this Ministry's O.M. No. 21(2)/2008-E-II(B) dated 29.08.2008.
