She did not join her duty at Bhavnagar and thereafter on request her place of posting was changed to CECRI and she joined her duty on 26.7.1995 i.e. after completing of one year.</p> <p>As per DoPT OM dated 06th June, 1978, in case a person joins his /her duty after six months of the offer of appointment, the name of the concerned person will be placed to the next year's batch and placed at the bottom in the seniority list.</p> <p>Therefore, the contention of Mrs. Padmavathi HR is not in order in view of the order of DoPT. It is also mentioned that the similar case of Shri CP Nawani who was senior to Mrs. Padmavathi in the panel but joined his duty after six months his name is also placed in the next vacancy year i.e. 1995-1996 above to Mrs. Padmavathi.</p> <p>The contention of the applicant is not in order. The seniority has been fixed in order of merit of CASE-97 which is already available in public domain. His name is fixed in the list in order of his merit.</p> <p>He is covered under the rules applicable on CSIR employees and not under CSS service.</p> <p>He has joined the services in CSIR after completion of pre-appointment formalities on 06.08.1992.</p> <p>The DoPT orders dated 20.4.2000 are not applicable on CSIR employees.</p> <p>In view of above, the vacancy year for fixing the seniority of Shri Prasad is 1992-1993 as he joined the post on 06.08.1992. Therefore, the seniority fixed earlier is in order.</p>
