

Sub:- Nomination of Presenting Officer in RDA Cases - regarding,
Sir / Madam,

As a matter of practice, now CBI does not nominate the Presenting Officer in RDA cases. In such cases, an officer from the Department concerned is appointed as Presenting Officer. It has come to the notice of the Commission that there is as yet a provision for nominating a CBI officer as Presenting Officer in certain type of cases.

2. It has been decided that if a Department/organization is of the view that a Presenting Officer from the CBI is a must, the concerned department/organization should furnish the reasons to the Commission and the Commission, in turn, will take it up with CBI for necessary action.
