





The promotees should join their new place of posting immediately but in any case within one month of issue of this order.

The promotees will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority.

The pay of the promotees will be fixed under the normal rules. However, they shall have the option, to be exercised within one month from the date of taking over charge of the post, for fixation of pay in the new post with effect from the date of appointment to the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22, under normal rules. The promotees will be entitled to TA/DA, joining time, joining time pay etc. as admissible under rules.

Even though transfer of officers at serial number 6, 7,9,10,11 and 16 of III above have been made on their own request, they are entitled to TA/DA, joining time, joining time pay etc. as admissible under rules as provided under Transfer Posting Guidelines.
