The Director General, CSIR has also been pleased to approve posting of Sh Gyanprakasam, SPO, IICT on promotion as CoSP at IICT, in the pay scale Rs 12000 – 375 – 16500 from the panel notified vide this Office Memo No. 3-33(84)1/2006 – EI dated 20.3.2006. He may join on or after January 1st, 2007. Sh Gyanaprakasam will be on probation for a period of one year from the date of taking over charge of the post. The probationary period may be extended or curtailed at the discretion of the competent authority. His pay will be fixed under the normal rules. However, he will have the option to be exercised within one month from the date of taking over of the charge of the post, for fixation of pay in the new post with effect form the date of the appointment to the new post or with effect from the date of increment in the lower post, in terms of the extant provisions of FR-22.
