## Amendment of Rule 7.5 of CSIR (Residence Allotment) Rules, 1997-reg. Sub:

Sir.

In pursuance of Govt. of India, Ministry of Urban Development (Order No. 13) below FR 45-A notified vide OM No. 12035/11/99-Pol.II, dated 24th July, 2003, I am directed to state that DG, CSIR in exercise of his power under Rule 1.3 of CSIR (Residence Allotment) Rules, 1997 has approved amendment to Rule 7.5 of CSIR (Residence Allotment) Rules, 1997 as under:

Slab of income from the house	Rates of the Licence fee to be recovered.
a) If income does not exceed Rs. 12,000/- p.m.	Normal licence fee
b) If income exceeds Rs. 12,000/- p.m. but does not exceed Rs. 20,000/- p.m.	-
c) If income exceeds Rs. 20,000/- p.m.	Three times the normal licence fee.

The remaining provisions of Rule 7.5 remains unchanged.

The above amendments shall be effective from 01.08.2012.
