Sub :- Details of vacancies, eligibility lists of candidates etc. – DPCs for vacancy year 2012-13 and 2013-14.

The meetings of DPCs for various Gr.'A' Common Cadre posts for the vacancy year 2012-13 and 2013-14 are likely to be convened from 16th Jan to 19th January 2013. In order to have greater transparency in the process, the following details are notified herein for information of all concerned:

- 1 Details of vacancies of COA/DS, AO/US, Sr.CoFA /Sr.Dy FA, CoFA /Dy FA, Sr.CoSP, CoSP, SPO.
- 2 Eligibility lists of candidates who are falling under ZOC - prepared according to para 6.1.1 of DoPT OM dated 10.04.1989.
- 3 The ZOC for the posts of US/AO/FAO/SPO is dependent, *inter-alia*, upon the resultant vacancies, which may vary depending upon the number of officers promoted to the next higher posts. **Therefore, if all the earmarked posts in the higher grades are not filled up, the ZOC may shrink and consequently some of the junior officers on the eligibility-lists may not be interviewed by the DPCs.**
