The financial up-gradation of the officer concerned under the ACPS will be subject to the following conditions:

- 1. The financial up-gradation under the ACPS shall be purely personal to the officer concerned and shall have no relevance to his seniority.
- 2. The ACPS envisages merely placement, on personal basis, in the higher pay scale / grant of financial upgradation benefits only and shall not amount to actual / functional promotion nor confer any privilege related to higher status except as provided under the scheme.

- 3. On up-gradation under the ACPS, the pay of the officer shall be fixed under the provisions of FR 22(I)a(1). The financial benefits allowed under the ACPS shall be final and no pay fixation benefits shall accrue at the time of regular promotion i.e. posting against a functional post in the higher grade.
- 4. The financial up gradation of the concerned officers under the ACPS shall also be subject to any other condition (s) as contained in DOPT OM No.35034/1/97-Estt (D) dated 9<sup>th</sup> August, 1999 circulated vide CSIR letter No.17/68/97-PPS dated 13.09.1999 as amended from time to time.
