The meetings of DPCs for various Group 'A' Common Cadre posts are likely to be convened shortly. In order to have greater transparency in the process, the following details are notified herein for information of all concerned.

- 1 Details of vacancies of Sr.CoA, COA/DS, AO/US, CoFA /Dy FA , FAO and Sr.CoSP , CoSP , SPO .
- 2 Eligibility lists of candidates who are falling under ZOC – prepared according to para 6.1.1 of DoPT OM dated 10.04.1989.
- 3 Name of those who were in service on the crucial date of eligibility i.e. 01.01.2014 but have retired before the date of commencement of the vacancy year i.e 01.04.14, of VY 2014-15 have not been included in the eligibility lists in terms of DoPT OM No.22011/3/98- Estt.(D) dated 14.08.2003.
- 4 The ZOC for the posts of AO/FAO/SPO is dependent, *inter-alia*, upon the resultant vacancies, which may vary depending upon the number of officers promoted to the next higher posts. **Therefore, if all the earmarked posts in the higher grades are not filled up, the ZOC may shrink and consequently some of the junior officers on the eligibility-lists may not be interviewed by the DPCs.**
- 5 The Directors concerned of the Labs /Instts are requested to send the Vigilance clearance /Integrity certificate and complete /Updated ACRs/ OAPARs dossiers of the officers whose names are appearing in the enclosed eligibility lists to this office latest by 15.05.14. The officers concerned are also requested to ensure that their ACRs/OAPARs are updated and complete in all respect as on 31.03.13.
