Minutes of the meeting held under the Chairmanship of Additional Secretary (S&V) on 15.01.2019 (Tuesday) at 03:00 PM hrs in Conference Hall, Room no. 190, North Block, New Delhi, to review status of the probity related information.

- 1. Additional Secretary (S&V) chaired a meeting with representatives of Cadre Controlling Authorities (CCAs)/ Ministries/ Departments on 15.01.2019 to review the action taken/ progress made by cadre controlling authorities/ Ministries/ Departments on the observations/ recommendations of CoS.
- 2. List of Participants is at Annexure-2. There was no representative from the O/o Comptroller and Auditor General.
- 3. At the outset, all representatives were informed about the directions/ recommendations of the CoS during their last meeting held on 01.11.2018 detailed as under for strict compliance:
 - (i) Ministries/Departments may ensure that special exercise is undertaken to complete the review of cases under FR 56 (j) and similar provisions.
 - (ii) Ministries/Departments may review and take action in respect of pending Disciplinary Proceedings and sensitive posts occupied by personnel beyond 03 years. Similar action may be taken in respect of various organisations under the Ministries/Departments. RTP may be implemented by all CCAs.
 - (iii) Ministries/Departments may ensure strict compliance of the timelines provided for completion of disciplinary proceedings.
 - (iv) Respective CCAs for All India Services officers may ensure that the review of officers is done by all the States and report is submitted timely.
 - (v) Pending Prosecution Sanctions may be disposed of expeditiously by all Ministries/Departments as per the amended provisions of PC Act, 1988.
- 4. It was also informed that with a view to ensure security and easier access through VPN, NIC-DoPT has proposed to shift the Probity portal to a new NIC server due to which the current URL (http://10.21.8.4/probitynew) will change. Technical Director, NIC-DoPT, clarified to participating officers that after logging on to Probity portal at the current URL, all existing users (except those accessing through VPN) would simply be redirected to the new URL and the user data would also be carried forward intact to the new URL. It was informed to all that instructions in this regard will be issued by DoPT separately.

5. The status of Probity related information furnished by CCAs/ Ministries/ Departments and the progress made by them are as follow:-

1	M/o Home Affairs	November 2018 data entered in Probity portal. It was informed by the representative that 4787 Group A officers out of 5177 due for review have been reviewed and 6663 Group B officers out of 7313 due for review have been reviewed. There are 65 posts being occupied beyond 3 years and 181 disciplinary proceedings pending in the Ministry, which have to be looked into on priority basis. It was also observed that there is a need to approach the States for completing review of IPS officers.	
2	M/o Railways	November 2018 data entered in Probity portal. It was informed by the representative that there are over 12,000 Group A and Group B officers in the Ministry, and out of these, 2685 Group A and 1502 Group B officers were due for review. It was further informed that review has been carried out among all but 1 Group A and 1 Group B officers due to be reviewed with provision of FR 56(j) invoked against 4 Group A officers. There are 204 disciplinary proceedings pending, which have to be expedited to ensure timely completion.	
3	M/o Defence	December 2018 data entered in Probity portal. While the total strength of officers in the Ministry is not available, there are 1183 Group A and 5260 Group B officers due for review, out of which 374 Group A and 3322 Group B officers have been reviewed. It was observed that there is a huge gap in 'number of officers to be reviewed' and 'number of officers reviewed'. The number of posts occupied beyond 3 years is also high at 48.	
4	D/o Defence Production	November 2018 data entered in Probity portal. It was informed by the representative that review data needs to be rectified in Probity portal due to duplication error. The revised figures for officers against whom FR 56(j) has been invoked are 14 Group A and 8 Group B officers against previous figures at 15 Group A and 24 Group B officers.	
5	D/o Financial Services	November 2018 data entered in Probity portal. It was informed by the representative that data needs to be rectified in Probity portal due to duplication error. There were 02 Group A officers due for review and both have	

		already been reviewed and found fit. 29 Group B officers due for review are yet to be reviewed by the Department. In respect of Public Sector Banks (PSBs), it was informed that there are 22 PSBs and 12 of them have individually entered data in Probity portal. The Department was also informed by NIC-DoPT that by logging on to Probity portal using the user ID "dept_psb" along with the associated password, the data entered by each individual PSB can be seen under the tab "Reports". Variance in data earlier entered by the D/o Financial Services for all PSBs and data entered by individual PSBs is required to be
		checked. Also, the number of pending disciplinary cases is very high at 1453. November 2018 data entered in Probity portal. It was
6	D/o Public Enterprises	informed by the Department that there were 02 Group A and 6 Group B officers to be reviewed, and their review has been already carried out. In respect of Central Public Sector Enterprises (CPSEs), It was informed by the representative that review data needs to be rectified in Probity portal due to duplication error. It was also informed that details of disciplinary cases could not be entered in Probity portal due to incompatibility of the format applicable to CPSEs with the format laid out in Probity portal. It was observed that there are 319 pending prosecution sanction cases and 6067 sensitive posts are being occupied for more than 3 years out of a total of 34329 sensitive posts.
7	D/o Science and Technology	November 2018 data entered in Probity portal. It was informed by the representative that data entered by the Department pertain to D/o Science & Technology, Survey of India, and NATMO. There are 124 Group A and 363 Group B officers due for review, out of which 102 Group A and 208 Group B officers have been reviewed. It was also observed that there are 2 disciplinary cases pending and 9 sensitive posts being occupied beyond 3 years in the Department. 25 autonomous organisations under the Department have separately entered data in Probity portal.

8	M/o Environment, Forest and Climate Change	November 2018 data entered in Probity portal. It was informed by the representative that there are 2 prosecution sanctions and 15 major disciplinary cases pending in the Ministry. It was also observed that there is a need to approach the States for completing review of IFoS officers. 1 autonomous organisation under the Ministry has separately entered data in Probity portal. November 2018 data entered in Probity portal. It was observed that there is a wide gap of over 2000 between number of Group B officers due for review and number of Group B officers actually reviewed. There are 10 prosecution sanction and 76 disciplinary cases pending in the Ministry. Out of 8659 sensitive posts, 60 of them are being occupied beyond 3 years. 9 autonomous organisations under the Ministry have separately entered data in Probity portal.	
9	M/o Housing and Urban Affairs		
10	M/o Power	November 2018 data entered in Probity portal. It was informed by the representative that review has been completed for all 138 Group A officers who due for review. As for Group B officers, 94 of them are yet to be reviewed. It was informed that significant number of reviews would be updated in December 2018 data. There are 7 sensitive posts being occupied beyond 3 years in the Ministry. 6 autonomous organisations under the Ministry have separately entered data in Probity portal.	
11	M/o Shipping	December 2018 data entered in Probity portal. It was informed by the representative that 41 Group A officers have been reviewed out of 53 to be reviewed, and 181 Group B officers out of 192 due for review. It was also observed that 16 out of 143 sensitive posts identified in the Ministry are being occupied beyond 3 years. Also, 1 autonomous organisation under the Ministry has separately entered data in Probity portal.	
12	Central Board of Direct Taxes	November 2018 data entered in Probity portal. It was informed by the representative that 277 Group A officers out of 487 due for review have been reviewed, and 2755 Group B officers out of 2817 due for review have been reviewed. It was observed that the number of pending disciplinary cases is very high at 184.	

Central Board of Indirect Taxes and Customs December 2018 data entered in Probity portal. It was observed that there is a wide gap of 6823 between number of Group B officers due for review and number of Group B officers actually reviewed. There are 6 prosecution sanction and 204 disciplinary cases pending in the Ministry. Out of the 204 disciplinary cases, 4 cases were disposed of and 4 new cases initiated during the previous month.

- 6. It was decided during the meeting that since there was a greater variance in data furnished in Probity portal especially by Department of Financial Services, Department of Public Enterprises and Department of Defence Production, these Departments are being allowed to carry out modification/ rectification by approaching DoPT/NIC with complete details for which rectification is required.
- 7. Additional Secretary (S&V) reminded that every CCA/ Ministry/ Department should take the review activity with utmost sensitivity while observing that more efforts are needed to ensure adherence to the timelines prescribed for prosecution sanction as well as disciplinary proceedings. Extensions, if so applicable, are to be processed by strictly following laid down rules. An official occupying a sensitive post for more than 3 years must be transferred out of that post positively. Additional Secretary (S&V) also desired that data furnished by CCAs are duly authenticated prior to entry in Probity portal, so as to avoid correction/ revision later on. He emphasized the importance of the entire exercise being undertaken by all CCAs and that queries on details of this exercise have become a routine question during each Parliament session. This has further necessitated that data put together by CCAs in the Probity system is consistent and robust, free from frequent alteration and backtracking. He desired that CCAs keep up the effort and continue to undertake this exercise in a consistent manner.
- 8. The meeting ended with a vote of thanks to and from the Chair.
