1. CSIR invites applications from eligible and interested officers in the prescribed format appended herewith for filling up the posts of Section Officers (General/Finance & Accounts/Stores & Purchase) on deputation basis for a period not exceeding three years as per the details given in this advertisement.
2. Pay Band : PB-2 ₹9300-34800; Grade Pay - ₹4800 + allowance as per Central Government rules, as made applicable to CSIR.
3. Eligibility Criteria : The applicant should meet the following eligibility criteria:-
  - (a) Should be working in an Institution/Organization or Autonomous Body of Central Govt.; and
  - (b) Should possess a University Degree; and
  - (c) Should be holding analogous/comparable Grade or has rendered 8 years service in the Grade of Assistant Gr. I in the PB-2 ₹9300-34800, Grade Pay ₹4200/- or ₹4600/-, on regular basis; and
  - (d) Max. Age limit is 40 years. Age limit is relaxable for SC/ST [5 years] /OBC [3 years]. For CSIR departmental candidates there is no age limit.
4. CSIR Departmental Assistants (General/Finance & Accounts/Stores & Purchase) Gr. I in the feeder cadre who are in the direct line of promotion will not be eligible for consideration for appointment on deputation for that respective cadre.
5. The Pay and other terms and conditions during deputation shall be governed by DOPT OM No. 6/8/2009-Estt. (Pay II) dated 17/6/2010, as amended from time to time.

6. The total period of deputation to CSIR shall not exceed three years. The deputationists shall not be eligible for permanent absorption or promotion in CSIR.
7. Subject to Para 3 & 4, a candidate may apply for one or more posts and Labs/Instts as per his/her choice. The appointment on deputation shall be made against specific post and Lab/Instt. The deputationist shall not be eligible to seek transfer to other Lab/Instt. 8. The appointment shall be made on the basis of recommendations of a duly constituted Selection Committee which shall interview the eligible candidates. In case of large no. of applications, the applications may be screened and/or a written test may be conducted prior to holding of interview. Details of the written test, if any, shall be notified on the CSIR website.
9. Outstation candidates appearing in the interview will be reimbursed to and from second class sleeper railway/ordinary bus fare for self only, subject to production of tickets, by the shortest route from the station nearest to the place of residence as mentioned in the application form or the place from where the journey is actually commenced to Delhi/New Delhi, whichever is less. No TA/DA shall be payable for attending the written examination, if conducted.
10. Last date for receipt of Applications through proper channel in CSIR is 01/08/2014. Applications through proper channel received after last date for whatsoever reason shall not be entertained. 12. Decision of CSIR with regard to the eligibility or otherwise of a candidate for selection to the post shall be final and binding.
13. Any outside influence (political or otherwise) brought in by a candidate shall disqualify him/her.
14. The eligible and interested candidates may apply on the prescribed application form appended herewith and ensure that the same is forwarded to CSIR by the respective Competent Authority along with the following documents, duly signed by an officer of the rank of Under Secretary or equivalent:-
