**Sub : Disposal of Representation in respect of Tentative details about ensuing DPC for Group 'B' CCOs – reg.**

**Ref : CSIR Web Notification of even number dated 27.10.2021.**

**A.** Vide CSIR letter dated 27.10.2021, the tentative eligibility list, vacancies details etc. were notified and it was informed that submission against above, if any, may be made by 08.11.2021.

**B.** In response to above, this office has received requests/information, which are as under, along with the decision of the Competent Authority: -

**(1) Sh. Anil Kumar, ASO(Gen), CSIR-CRRI, New Delhi :-**


Vide CRRI letter dated 12.11.2021, a request dated 11.11.2021 of Sh. Anil Kumar has been forwarded wherein he has informed that in the CSIR All India Seniority List dated 03.07.2020 of ASO (Gen), his name is mentioned at SI. No. 81 and his category had not been mentioned in the aforesaid list. He has stated that his category is "Scheduled Caste" that can be verified from his service and official record. He has further stated that as per the EZOC list, the name of Shri. D. Rajak is included in the EZOC at SI No. 63 who is junior to him. He has requested that his category may be corrected as "Scheduled Caste" and his name may be included in the list.

**Decision of Competent Authority:-**

CSIR-CRRI, New Delhi vide latter dated 12.11.2021 has informed that as per their official records, Sh. Anil Kumar, ASO(Gen), CSIR-CRRI, New Delhi belongs to 'SC' category, Accordingly, the request of Sh. Anil Kumar has been acceded to and 'SC' category is added against his name.

**(2) Sh. Ghayas Uddin, ASO(F&A), CSIR-NBRI, Lucknow :-**

Vide NBRI letter dated 03.11.2021, a request dated 01.11.2021 of Sh. Ghayas Uddin has been forwarded wherein he has stated that his name is at SI. No. 20 in the eligibility list dated 27.10.2021 but his vigilance clearance has not been solicited from his employer i.e. Director, CSIR- NRBI, Lucknow and requested to consider his candidature for the post of SO (F&A) under DPC quota.

**Decision of Competent Authority:-**

Vide CSIR letter dated 27.10.2021, Vigilance Clearance of ASOs has been solicited in anticipation of vacancies viz-a-viz seniority and for the candidates likely to be in Vacancy Zone. As per rule if sufficient number of candidates are available within the vacancy zone then rest of candidates need not be assessed by DPC. Accordingly, the request of Sh. Ghayas Uddin has not been acceded to.

**(3) Sh. Arun Kumar Sharma, ASO (S&P), CSIR-IGIB, New Delhi :-**

Vide IGIB letter dated 05.11.2021, a request dated 01.11.2021 of Sh. Arun Kumar Sharma has been forwarded wherein he has stated that in all India seniority list dated 03.07.2020, his name was placed at Sl. No. 39 which was not correct and subsequently vide circular dated 27.10.2021 his name is completely removed from All India Seniority List without any reason. Further, stated that earlier he had submitted a representation to remove the anomalies and he was communicated with a reply from CSIR that his name will be placed at the right place in next seniority list. Next list came this year on 27.10.2021 and instead of placing his name at right place, his name was removed from the seniority list of ASO(S&P).

**Decision of Competent Authority:-**

It is informed that vide CSIR letter dated 27.10.2021, tentative eligibility list of ASOs has been issued for Group 'B' for DPC VY-2020 and it is not the All India Seniority list. Further, on perusal of records it is noted that Sh. Arun Kumar Sharma is placed in All India Seniority List dated 10.06.2011 (available on CSIR website) at sr no. 160 of ASO (S&P) under DTQ (TURS) and his seniority issue is already well settled. In the latest All India Seniority List issued on 03.07.2020, he is placed at sr. no. 39. Accordingly, the request of Sh. Arun Kumar Sharma has not been acceded to.

All the above representations stand disposed of accordingly.
