Subject : CSIR-Humboldt Reciprocity Awards to German Scientists for 2010

Sir,

As part of the reciprocity arrangement with Alexander von Humboldt Foundation, Germany, CSIR is obliged to grant two awards to internationally renowned German scientists every year. The German award winners are invited to carry out research projects of their own choice at the Indian research institute for a period ranging between 2 weeks to 4 months, extendable upto one year. The research project may be prepared in consultation with the Indian host institute and should be relevant to and falling in the priority/thrust areas of CSIR.

2. Nominations of internationally recognised German scholars, willing to be considered for this prestigious reciprocity award for the year 2010 for spending time in the Indian research institute, are invited for consideration.

3. 10 copies of the nomination applications and an electronic copy may please be sent to ISTAD, CSIR on the prescribed format at Annex-I * before the deadline of 10th October 2009. Call for Nominations of German Scholars for the CSIR-Humboldt Reciprocity Research Award for 2010

CSIR has an agreement with Humboldt Foundation, Germany for granting the CSIR-Humboldt Reciprocity Award to internationally renowned researchers of India and Germany annually in the disciplines of science and engineering in recognition of their internationally renowned past achievements in research and for promoting cooperation between India and Germany. Under this programme the award is granted to two Indian and two German experts annually to work on the research projects at their host institutes in the counterpart country. The award entitles the German award winner to spend short term/long term research stay at the Indian R&D institutions. This prestigious award is intended as a lifelong tribute to the past academic/research accomplishments of the award winners. (Information on nomination procedure for Indian experts may be downloaded from website www.humboldt-foundation.de)

The Alexander von Humboldt Foundation (AvH) promotes an active world-wide network of scholars. In addition to India, Humboldt Foundation operates such Reciprocity Award Programmes with partner organisations in various countries like Australia, Belgium, Brazil, Canada, Chile, Denmark, Finland, France, Hungary, Israel, Japan, Korea, the Netherlands, Poland, South Africa, Spain, Sweden.

The German award winners are invited to carry out research projects of his/her own choice, which may be prepared in consultation with the Indian host institute and should be relevant to and falling in the priority/thrust areas of CSIR.

Value of Research Award

CSIR would provide international travel and hospitality in India as per the following details :

- 1) Per diem amount : Rs 36,000 per month (Rs 1200/- per day)
- 2) Accommodation : in a reasonably good CSIR Guest house/3-4 star hotel wherever guest house accommodation is not available.
- 3) Travel : Round trip airfare only once. Inter-city travel to relevant CSIR institutes by air (economy class) and train (first class A/C), wherever air connections are not available/not convenient.
- 4) Travel expenses for family: Round trip travel expenses upto the CSIR host institute for spouses and maximum of two children aged under 18 years if accompanying the Awardee for a minimum of 4 months. CSIR can provide coordination assistance in organizing their visits to other cities in India.
- 5) Participation in Conference etc.: Only active participation of German Awardees in the relevant conferences/workshops in India will be supported on request by the host CSIR institutes.

Duration of stay

The award winners are invited to participate in the research activities of the Indian host R&D institutes and to carry out research projects in cooperation with the Indian colleagues for periods from 2 weeks to 4 months and extendable upto one year. Visits with longer duration will be preferred. The awardee must stay minimum for a period of **two-third of his/her total stay approved at the host CSIR institutes.**

Nomination Requirements

Full professors and scholars of equivalent status engaged in non-university/applied research from the disciplines of priority of CSIR may be nominated for the Humboldt Research Award. The academic qualifications of the nominee must be internationally recognized and documented by proven success in research such as positive responses to the nominee's published work and previous distinctions.

The nominating scientist/institute is required to guarantee that sufficient infrastructure, material, equipment and the assisting staff are available and access to archives and libraries is assured, enabling nominees to successfully carry out research projects. Indian hosts must make all necessary arrangements for award winners' research visit to India and be responsible for their well being (e.g. arranging /assisting in accommodation, travel etc).

Nomination Procedure

CSIR makes call for proposals only once a year for inviting nominations of German Scholars for CSIR-Humboldt Research Award. The applications must be made as per the prescribed format and submitted to CSIR HQs. Decision on nominations is made by a duly constituted Selection Committee by CSIR, which meets only once a year.

Institutes falling under major scientific agencies and Institutes of National Importance in Academic Sector may make nominations jointly with relevant CSIR institutes. The area of research of the German awardee should, however, fall under the priority/thrust areas of CSIR and the German awardee would need to spend minimum two-third of the total stay approved at the relevant CSIR institute(s). Ten copies of the nomination applications along with an electronic copy may be sent by post to Head, ISTAD, Council of Scientific & Industrial Research, Anusandhan Bhavan, 2, Rafi Marg, New Delhi-110001 latest by **October 10, 2009.**

Nomination documents should essentially include the following documents:-

- the completed nomination form;
- a chronological list of nominee's academic publications from the past 10 years;
- some off-prints and copies of the nominee's important, more recent academic publications;
- names (with correct postal addresses) of at least three foreign, three German and three Indian scientists or scholars who can provide information about the qualifications, scientific contribution in the area of research of the nominee. Please do not cite referees from either the nominee's or your own institution.
- a draft of the project (two to three pages) outlining the research the nominee would like to conduct if invited to come to India as an award winner.

Incomplete applications will not be considered.
