INSTRUCTIONS FOR CANDIDATE

- 1. Candidates must **show their official ID Card** before they are allowed inside the examination hall. Candidates coming to the examination centre without office ID Card will not be allowed.
- 2. Candidates may please note the issue of Roll Number / Admit Card does not confer any right for appointment to the post for which they are applicant.
- 3. Candidates may check for the accuracy of the information as regards name, designation, etc. printed on the Roll Number / Admit Card. In case of any discrepancy, they are requested to indicate the same to the Center Coordinator.
- 4. Candidates will be allowed to take the examination only at the centre specified by them in their application form. Any request for change of center / venue will not be entertained.
- 5. Candidates in their own interest may ensure the location of their Centre / Venue one day before the date of Examination.
- 6. Candidates in their own interest should be present in the Examination Hall half an hour before commencement of the examination.
- 7. Candidates will have to bring their own stationery- ball point pen, Pencil, eraser etc.
- 8. No candidate will be admitted to the Examination Hall half an hour after commencement of the Examination.
- 9. The candidate should fill in the requisite relevant information in spaces provided for writing Roll No. etc. in the Answer Book/Sheet.
- 10. Candidates should answer in the medium (either Hindi or English) they have opted in their application form
- 11. No candidate shall be permitted to leave the Examination hall earlier than 45 minutes after commencement of the exam.
- 12. No candidate shall leave the Examination hall without proper permission of the Supervisor / Invigilator and without handing over Question Paper, Answer Booklet to the Supervisor / Invigilator.
- 13. The Answer Booklet has to be deposited at the end of the examination. Candidates failing to deposit the same shall stand disqualified and may be liable to suitable action as per rules.
- 14. Candidates must abide by the instructions given in the Question Paper / Answer Booklet and those given by the Supervisor/Invigilator. Failure to follow directions will make the candidates liable to any such penal action as the Council may decide.
- 15. Candidates **should not carry** any paper inside the Examination Hall except for the Admit Card. It may kindly be noted that Bags reference, Books, notes, calculators, laptops, mobile phones etc are not allowed inside the examination hall.
- 16. Need be there, the Coordinator of the Centre, the Invigilating staff or any other examination team may carry out such physical search of the candidates before they enter the examination hall or anytime during the course of the examination as may be required to ensure that the candidates do not have any unauthorized material in their possession.
- 17. Candidates found using or attempting to use any unfair means shall forfeit his/her Candidature apart from suitable action as deemed fit.
- 18. Candidates must maintain absolute silence and must not disturb other candidates sitting in the examination hall.
- 19. Candidate should not tear off any leaf from his/her Test Booklet.
- 20. Smoking, consumption of tea/eatables in the Examination Hall is strictly prohibited
