6. A copy of latest **Annual Property Return (APR)** in accordance with CVO Circulars No. 15-6(82)/98-O&M-II(Vig.) dated 08.03.2019 and No. 15-1(154)/2019-Vig dated 05.04.2019.

**C.** Further, an **Integrity Certificate** stating that "The records of service of the Officer(s) who is/are to be considered for promotion have been carefully scrutinized and it is certified that there is no doubt about his/her/their integrity", may also be furnished.
