Sub:- Furnishing of complete information in the Quarterly Report on Action Plan on Vigilance and Anti-Corruption Measures.

Reference is invited to Council of Scientific and Industrial Research (CSIR)'s ID Nos. 15-1(95)/2003/Qtr.III/Vig. and 15-1(95)/2003/Qtr.IV/Vig. dated 31.12.2018 and 12.02.2019 received along with Quarterly Report on Action Plan on Anti-Corruption Measures for the quarter ending 30.09.2018 & 31.12.2018, respectively.

- 2. On perusal of the report, it has been observed that requisite data/details on cases pending decision over 6 months after CVC 1st stage advice; cases pending decision over 6 months after CVC 2nd stage advice; and number of cases pending sanction for prosecution in CBI cases have not been mentioned in the report. Further, the number of pending major penalty proceedings for more than one year (79, 80, and 83, respectively) are appears to be very high.
- 3. It is, therefore, requested that appropriate action may kindly be taken in this regard and also to submit Quarterly Reports/Statements for the Quarter ending March, 2018; June, 2018; September, 2018 and December, 2018 with complete information in the prescribed format (enclosed) to this Department, expeditiously, so as to enable it to further process the matter accordingly.
