2. Now, that the results in respect of General Election to the State Legislative Assemblies of Assam, Kerala, Tamil Nadu, West Bengal and Puducherry, 2021 and bye-elections to various Parliamentary and Assembly constituencies in various States have been

declared by the respective Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect.
