The Directors/Heads of All CSIR Labs/Instts/Units

Madam/Sir,

It is informed that as per Deptt. of Expenditure OM dated 15th May 2020, no Global Tender can be floated for tender upto Rs.200 Cr without specific approval of Secretary (Coordination), Cabinet Secretariat. Further, as per DPIIT order dated 4th June 2020, no nonlocal supplier can participate in any of the tenders upto Rs.200 Cr except when Global Tenders are floated with the approval of the said Competent Authority.

The above two policy changes have brought in new challenges to procurements of goods required for R&D. In order to mitigate these difficulties a proposal was submitted to MoF to delegate the powers to allow Global Tenders in CSIR to the Directors of the CSIR Labs/Institutes. MoF, DoE have in turn sought certain statistics. In order to strengthen our case, it is therefore, necessary to provide details of goods required for R&D which need to be specifically imported for which no local/indigenous source/ manufacturer is available. This information is to be immediately compiled and provided by PME as per para 2.10 of the CSIR Manual of procurement of Goods 2019 as per the format attached. The information may kindly be provided for FY 2020-21 in word file only (no PDF).

Considering the urgency of the matter, you are requested to submit the above information so as to reach CSIR Hqrs by 15th July 2020 (as per Format attached) so that Ministry of Finance could be once again apprised of the requirement of CSIR. Any delay in receipt of the input from the Labs/Instts. will necessarily delay taking up the matter with MoF and consequently a delay in procurements.
