Sir/Madam,

Integrity Pact is a powerful tool to combat corruption and bring transparency in the government dealings. However, instances have been brought forth to the notice of the undersigned that Integrity Pact is not followed scrupulously in CSIR.

In this regard it is informed that Para 3.3.2 of the CSIR Manual of Procurement of Goods 2019 inter-alia mentions that Ministry of Finance, Department of Expenditure have **mandated** vide their OM No. 14(12)/2008-E.II(A) dated 19th July 2011 that Ministries'/Departments and their attached/subordinate offices (including autonomous bodies) to incorporate Integrity Pact and the threshold limit for implementation of Integrity Pact in CSIR would be informed separately. Moreover, the CSIR Circular no. 13-4(04)/15-16/S&P/Policy dated 27th June 2019 informs that the decision on the threshold limit for implementing the Integrity Pact is under consideration & would be informed separately and till such time the existing limit of Rs. 3.00 crores may continue without relaxation during the intermittent period.

In view of the aforesaid, it is imperative that the Integrity Pact should be followed scrupulously in letter and spirit.

Further, it is requested to provide the details of the procurements/contracts; in proper sequence; for the past five years, as per Annexure 'A'.
