Sub : Meetings of the Departmental Promotion Committees (DPCs) to consider promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2019 - reg.

Sir,

I am directed to state that meetings of the DPCs have been convened on 11th, 16th & 20th December, 2019 at CSIR Hqrs, New Delhi to consider the cases of eligible Officers for promotion to the next higher grades/posts.

2. The enclosed list contains the names of Officers of all the Labs/Instts called for interview along with their date of interview and time. It may be noted that:-

- (i) The ZOCs for the posts of US/AO, Dy. FA/COFA, F&AO and SPO are dependent, inter alia, upon the resultant vacancies. It is presumed that all the vacancies in the higher posts will be filled up and all the resultant vacancies will be available. If this does not happen, the total vacancies and consequently ZOC will get reduced and some of the junior officers in the enclosed lists may not come in the consecutive revised ZOCs and hence such officers will not be eligible for appearing in the interview. Therefore, ZOCs for the aforesaid posts may undergo a change depending upon the results/outcome of the DPCs for respective higher posts.
- (ii) The eligibility list/ZOC for the post of DS/COA is in accordance with the Hon'ble Punjab and Haryana High Court Judgment dated 17.12.2018 in CWP No. 20984 of 2016 and without prejudice to the right of CSIR to issue other order(s) that may be necessary in pursuance of aforesaid Judgment dated 17.12.2018.
- (iii) The promotion panels will be subject to the outcome of various court cases. Further, panels for the posts of US/AO, F&AO and SPO will be subject to further orders of Hon'ble Supreme Court in various cases mentioned in DOPT OM No. 36012/11/2016-Estt. (Res-I) {Pt-II} dated 15.06.2018 and/or in any other case related with the matter of reservation in promotion.
- (iv) The Officers should report 30 (Thirty) minutes before the scheduled time.
- (v) Further, the Officers may be required to stay for next day also, in the eventuality of all the candidates not being interviewed on the scheduled date. Therefore, they should plan their journey accordingly.
- (vi) The Officers are entitled for TA on tour, without DA, as admissible under the rules.

- (ii) direct the concerned Officers of your Lab/Instt to attend the interview as per their respective dates indicated in the schedule;

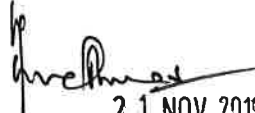

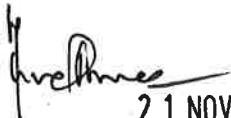
