Sir.

I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of election schedule by the Election Commission and it remains in operation till completion of election process.

- Now, that the results in respect of General Elections to State Legislative Assemblies of Goa, Manipur, Punjab, Uttarakhand and Uttar Pradesh, 2022 and bye election for one Assembly Constituency in Assam have been declared by the respective Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect except in the districts of Uttar Pradesh where Model Code is in force due to biennial election to Local Authorities' constituencies of Uttar Pradesh Legislative Council.
- 3. This may be brought to notice of all concerned.
