Sub:- Redressal/disposal of Public Grievances on CPGRAMS in a time bound manner-reg.

Sir/Madam,

I am directed to refer to the guidelines issued by Department of Administrative Reforms & Public Grievances from time to time for prompt and effective redressal of public grievances. The compilation/guidelines are available at www.darpg.gov.in and www.pgportal.gov.in. Accordingly, public grievances should be redressed within a period of two months from its receipt. All COVID-19 related public grievances should be redressed at the earliest/ within a timeline of three days. Cases where immediate resolution is not possible due to long term policy issues or legal implications, the citizen shall be informed suitably . Further, if finalization of a decision on particular grievance is anticipated to take more than the prescribed timeline, an interim reply should invariably be sent to the petitioner.

The number of grievances pending on PG Portal in respect of CSIR Labs/ Institutes/Units/CSIR Hqrs. are enclosed as Annexure-I. It is observed that some grievances are pending even after considerable lapse of time.

It is requested that the grievances may be addressed promptly and timelines may kindly be adhered to. Further, pending grievances on CPGRAMS may kindly be examined & redressed/disposed at the earliest and action taken report/ copy of reply sent to the petitioner may also be uploaded on PG Portal .
