

**Sub : Action taken on Representations received against ensuing DPCs for Gr. B CCO**

CSIR vide web notification of even no. dated 07.11.2014 had issued tentative details of vacancies & eligibility lists etc., for the ensuing DPCs for promotion to the posts of SOs (Gen/F&A/S&P) and PS for the Vacancy Year 2013-14 (2<sup>nd</sup> DPC) and 2014-15 with the request that if anybody has any submission against the proposed eligibility lists and the vacancy position etc., the same may be emailed to this office latest by 14.11.2014.

The details of the representations received and action taken thereon are as under:-



I to SO (S&P) is on the basis of <b>Selection-cum-Seniority</b> subject to rejection of unfit. In this mode, the concept of Zone of Consideration (ZOC) applies and name of Sh. Anand does not come in the ZOC.  <b>Therefore, his request cannot be acceded to.</b>
2.	Sh. Dhananjay Kumar Singh NPL Email No. DKS/4592/125 /F&A/NPL dated 14.11.2014	Asstt. (F&A) Gr. I	Seniority list of Asstt. (F&A) Gr. I is not in order/not justified as the same was not available on CSIR website or through official communication for DPC in r/o Asstt. (F&A) Gr. I. He has not been enlisted for DPC despite being eligible.	The All India Final Seniority lists of Asstt. (F&A) Gr. I & Asstt. (S&P) Gr. I was issued last time vide CSIR letter No. 3-5(C)/2007-EI dated 10.06.2011. The manner of the preparation of the list was also stated in the aforesaid letter.  The list of Asstt. (F&A) Gr. I has been challenged in various court cases and result of DPC shall be subject to outcome of these cases.  <b>The updated list will be issued after finalization of court cases.</b>
3.	Sh. L.R. Kaushik IIP Email dated 10.11.2014	Asstt. (S&P) Gr. I	He has requested to correct his date of joining as Asstt. (S&P) Gr. I as 20.01.1999 instead of 20.10.1999.	His date of joining as Asstt. (S&P) Gr. I has been corrected as 20.01.1999 in the Seniority List.





4.	Ms. Remani Devaraj NIIST Email dated 12.11.2014	Asstt. (F&A) Gr. I	She has stated that her name was included in the Seniority List of Asstt. (F&A) Gr. I issued on 24.04.2006 and 10.10.2007 but her name was not included in the successive lists issued on 25.09.2008 and 10.06.2011.	<p>Her name was included at S.No. 45 in the Seniority List of Asstt. (F&amp;A) Gr. I issued vide CSIR letter No. 3-33(125)/2006-EI dated 24.04.2006. In the list issued vide CSIR letter No. 3-5(C)/2007-EI dated 10.10.2007 her name was at S.No. 40.</p> <p>It appears that inadvertently her name was not included in the Seniority Lists of Asstt. (F&amp;A) Gr. I issued vide CSIR letter No. 3-5(C)/2007-EI dated 25.09.2008 and 10.06.2011.</p> <p>It also appears that she did not submit any representation against exclusion of her name from the Seniority List issued on 25.09.2008.</p> <p>Her name has been included in the Seniority List of Asstt. (F&amp;A) Gr. I issued vide CSIR letter No. 3-5(C)/2007-EI dated 10.06.2011 at the appropriate place i.e. at S.No. 25A between S.No. 25 (Sh. C.V. Bala Subramanian) and S.No. 26 (Sh. Ashok Raju G).</p>

I on 31.08.2005.	<p>It is noticed from the documents attached with CECRI letter dated 11.11.2014 that Sh. S. Ramakrishnan had opted for the F&amp;A cadre at UDC level and later on he was promoted from Asstt (F&amp;A) Gr. II to Asstt (F&amp;A) Gr. I on 31.08.2005.</p> <p>This case requires in depth examination and will be done separately.</p>

Formal amendments in the All India Final Seniority lists of Asstt. (F&A) Gr. I & Asstt. (S&P) Gr. I, issued vide CSIR letter No. 3-5(C)/2007-EI dated 10.06.2011, will be issued separately after completing in depth examination proposed in case of Sh. S. Ramakrishnan, Asstt. (F&A) Gr. I, CECRI as this is not affecting the eligibility list for the current vacancy year. Till that time this web notification will remain a part of the aforesaid CSIR letter dated 10.06.2011.
