


I am directed to state that the operation of revised screening criteria notified vide this office letter of even number dated 14.2.2012 have been kept in abeyance. Further, DG,CSIR has approved processing of assessment cases fallen due in assessment year 2012-13 onwards following the original screening protocol prescribed under rule 7.4 of CSRAP Rules 2001 which is reproduced as under:-

## **Rule 7.4**

All Scientists will be first screened for eligibility on the basis of gradings in the Annual Confidential Reports (ACRs) and only those Scientists who satisfy the minimum residency period linked to their performance threshold scores as indicated in the Table below shall be considered for further assessment:
