***Note reg. NFS** - As per CSIR letters No. 3-33(113)/2004-EI and 5-1(3)/2008-PD dated 04/10/2008, w.e.f. 03/10/2003, SOs (Gen/F&A/S&P) and PSs, who have completed 04 years of approved service, are eligible for grant of NFS, subject to vigilance clearance.

Sh. Yatinder Chauhan had been promoted to the post of SPO 07/05/2004. Also, in the data forwarded in r/o many F&AOs, NFS w.e.f. 03/10/2003 has not been shown. It appears the Labs/Instts concerned inadvertently did not initiate action to grant such CCOs benefit of NFS.

As per rules, NFS is counted towards one financial upgradation. Therefore, the same is required to be shown in the eligibility list.

In view of the above, Labs/Instts may initiate action to grant CCOs benefit of NFS as per their eligibility and prescribed procedure, if the same has not been granted to them earlier.
