Department of Personnel and Training, inter alia, deals with policy of reservation for Persons with Disabilities in the posts and services of the Government of India. As per the extant instructions, three percent of vacancies are reserved for Persons with Disabilities, wherever it is applicable, of which one per cent shall be reserved for persons suffering from (i) blindness or low vision, (ii) hearing impairment and (iii) locomotor disability or cerebral palsy, in the posts identified for each disability.
