OFFICE MEMORANDUM

Subject: CWP No. 11444 of 2013 in the matter of Adarsh Kumar Vs. Union of India- Issue of promotion in CBDT

Department of Personnel and Training, inter alia, deals with policy of reservation for Persons with Disabilities in the posts and services of the Government of India. As per the extant instructions, three percent of vacancies are reserved for Persons with Disabilities, wherever it is applicable, of which one per cent shall be reserved for persons suffering from (i) blindness or low vision, (ii) hearing impairment and (iii) locomotor disability or cerebral palsy, in the posts identified for each disability. It has been decided to collect and collate the following information to consolidate the information pertaining to the filling up of vacancies for Persons with Disabilities :-

- (i) Number of advertisement issued in the last 10 years and the number of posts advertised for Persons with disability- category-wise and year-wise
- (ii) Number of post filled up by the persons with disabilities and remaining unfilled vacancies with the reasons for not filling up of vacancies reserved for persons with disabilities.

2. It is requested that the above information pertaining to the Ministry/Department as well as the attached/subordinate offices and the Central Public Sector Undertakings may be kindly be provided by 30th June, 2015.
