Sir,

I am directed to refer to your letter ref. No. 5-1(274)/2015-PD dated 10.06.2015, regarding the directives on recent Judgment of Supreme Court on Jat Community. I am directed to inform you that the Notification No. 63 dated 04.03.2014 of the Central Government including the 'Jat caste/community in the Cental List of Other Backward Classes for the States of Bihar, Gujarat, Haryana, Himachal Pradesh, Madhya Pradesh, NCT of Delhi, Bharatpur & Dholpur Districts of Rajastha, Uttar Pradesh and Uttarakhand has been set aside and quashed by the Supreme Court in the Judgment dated 17.03.2015 in Writ Petition No. 274 of 2014 (Ram Singh & Ors Vs Union of India). Therefore, as per the Judgment, the 'Jat' caste/community are not to be treated under the OBC quota. As the Government of India's notification including the 'Jat' caste/community in the Central List of OBCs is set aside and the same is no more in force, the Judgment of the Supreme Court is binding on all and is enforceable throughout the India under Article 142 of the Constitution of India.

2. The 'Jat' caste/community is also not shown presently as OBC on the NCBC website. Therefore, you are requested to act in accordance with the aforesaid judgment of the Supreme Court.
