Sub: Settlement of outstanding Audit paras of the Inspection Report (IR)

Sir,

Dy. Director (Inspection), PDA, C&AG vide their letter No. PDA(SD)/Inspection/2/127/Settlement of O/S Paras/ 2015-16/628 dated 26.10.2015 have raised the issue of large number of outstanding audit paras of IR with various Lab/ Institutes.

2. While consolidating the records in the CSIR Headquarters it has been noticed that more than one thousand Inspection paras have been pending for various reasons in CSIR Lab/

Institute.

3. The matter was discussed in the Standing Audit Committee (SAC) of CSIR and DSIR which met on 11.04.2016. The following steps were recommended by the Committee:

i. The laboratories/ Institutes will prepare the replies of all the IR paras immediately.

ii. The replies would be got vetted by the adhoc committees as per Office Orders No. 6(2)/87-Reports dated 18.06.87, 23.01.1991 and DO Letter 26.03.2002 (copies enclosed). The reasons for the delay in settling the paras may be recorded in the prescribed format provided in the DO Letter No. 29/6(2)/87-Reports dated 26th March, 2002.

iii. The Adhoc Committee has a provision to invite Resident Audit Officer of the respective zones of PDA, C&AG as observer. The Labs/Institutes are requested to invite the Resident Audit Officer and get the paras dropped. This procedure may be completed latest by 31.05.2016 and the outcome may be intimated to CSIR

Headquarters.

iv. After completion of this exercise a copy of the replies of the unsettled paras containing the reasons of deadlock with the audit may be provided to CSIR Headquarters so that the matter may be taken up with the respective zonal office of the PDA, CAG.

- 4. As no reports were forthcoming, another communication dated 23rd January, 91 was sent to Laboratories to forward the following information:
 - (a) Copy of the O.M. constituting ad-hoc committee along with information regarding dates of meetings held in each quarter during the period from June 1987 onwards and progress achieved from time to time.

- (b) An up-to-date list of all outstanding paras of Inspection Report/Audit Reports issued by Principal Director of Audit (Scientific Departments) along with brief description of paras and reasons for their non-settlement.
- 5. Inspite of clear-cut instructions, the laboratories/Institutes have not followed the system of constitution of Ad-hoc Committees with the result the number of audit paras/objections have grown out of proportions.
- 6. To obviate any further criticism from Audit and also in accordance with the instructions issued by the Ministry of Finance from time to time, I would request you to follow the instructions as circulated vide Office Order No.6(2)/97-Reports dated 18.6.87 & 23rd January, 1991 (Copy enclosed) in letter and spirit. As a first step, Ad-hoc committee as per the constitution indicated above may be constituted and a copy of the notification forwarded to me immediately along with brief description of outstanding audit paras in the following format:
