3. As per Clause 15 of MACPS, the due dates) of eligibility in r/o officers at Para 2 above have been deferred for one year w.e.f. the date(s) shown against their names. Hence their names have also been included in the final list with the new dates of eligibility.

4. In the previous meeting of the Screening Committee held on 21.04.2014, the case of Sh M.N. Shaikh, SO(S&P) was deferred due to non availability of his ACRs. Since, his ACRs have been received from the respective lab, his name has been included in the final list.

5. Case of Shri M.L. 
