

**Sub Tentative Details of Vacancies and Eligibility Lists etc. for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2019 - reg.**

The meetings of DPCs for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2019 are being convened shortly. In order to have transparency in the process, the following details are notified herewith for information of all concerned:-

1. Details of vacancies of DS/COA, US/AO; Sr. Dy. FA/Sr. COFA, Dy. FA/COFA, F&AO; COSP and SPO. The exact number of vacancies depend upon various factors and, therefore, may vary at the time of holding of DPC.
2. The ZOCs for the posts of US/AO, Dy. FA/COFA, F&AO and SPO are dependent, inter alia, upon the resultant vacancies. It is presumed that all the vacancies in the higher posts will be filled up and all the resultant vacancies will be available. If this does not happen, the total vacancies and consequently ZOCs will get reduced and some of the junior officers notified in the instant eligibility lists may not come in the consecutive revised ZOCs.
3. Eligibility Lists and ZOCs have been prepared in accordance with the guidelines contained in DOPT OM Nos. 22011/1/90-Estt(D) dated 12.10.1990 & 22.04.1992.
4. The promotion panels will be subject to the outcome of OAs pending before different benches of the Hon'ble CAT. Further, panels for the posts of US/AO, F&AO and SPO will be subject to further orders of Hon'ble Supreme Court in various cases mentioned in DOPT OM No. 36012/11/2016-Estt. (Res-I) {Pt-II} dated 27.06.2018 and/or in any other case related with the matter of reservation in promotion.
5. Officers included in the eligibility lists are advised to ensure that their ACRs/O-APAR folders upto 31.03.2017 i.e. upto the Year 2016-17 are complete in all respects.
