Subject: Insertion of a specific clause in the tender documents stating that Clause 10(d) of Public Procurement (Preference to Make in India) Order 2017 (PPP-MII Order 2017) would be invoked wherever applicable.

Sir/Madam,

I am directed to invite your attention to this office letter of even number dated 1<sup>st</sup> August, 2019 whereby DPIIT Order No.P-45021/2/2017-PP(BE-II) dated 29<sup>th</sup> May, 2019 on the revised PPP-MII Order 2017 was endorsed for information and compliance.

2. The Paragraph 10(d) of the said order reads as under:

*"If a Nodal Ministry is satisfied that Indian suppliers of an item are not allowed to participate and/or compete in procurement by any foreign government, it may, if it deems appropriate, restrict or exclude bidders from that country from eligibility for procurement of that item and/or other items relating to that Nodal Ministry. A copy of every instruction or decision taken in this regard shall be sent to the Chairman of the Standing Committee. "*

3. The Committee of Secretaries vide e.Samiksha UID No.CoS/4897/7 has decided that all Ministries/Departments may ensure that the tender documents state that Clause 10(d) of the PPP-MII order 2017 will be invoked wherever applicable. It has further directed that in case of invocation of clause 10(d) of the PPP-MII Order 2017, single bids can be accepted. Also in order to control tender pricing, benchmarking of prices may be done.

4. In view of the above decision of the Committee of Secretaries, an appropriate clause may be incorporated in all tender documents that the reciprocity clause 10(d) may be invoked in terms of the stipulation of the said clause. Further, a copy of every instructions or decision shall be sent to Chairman of the Standing Committee of DPIIT with a copy to CSIR Hqrs.

5. All Labs/Instts. are accordingly directed to ensure that an appropriate clause as explained above, is incorporated in all the tender documents for inviting bids/tenders in future.
