

Office Memorandum

Subject: Modalities /Scheme of Amalgamation of Consultancy Development Centre (CDC) with Council of Scientific and Industrial Research (CSIR) - reg.

Consequent upon the Government of India, Department of Scientific & Industrial Research (DSIR) Notification No. AB-CDC018/1/2021-PSE-DSIR dated 11.05.2022 notified in the Gazette of India on 12.05.2022, the DG, CSIR, in consultation with FA, CSIR, has approved the following Modalities of Amalgamation of Consultancy Development Centre (CDC) along with all manpower, moveable assets and liabilities of CDC with Council of Scientific and Industrial Research (CSIR):

1. The amalgamation of CDC with CSIR has come in to effect from date of notification of Amalgamation of CDC with CSIR by DSIR i.e. 12.05.2022.
2. All manpower, moveable assets and liabilities of CDC shall stand transferred from CDC to CSIR.
3. All Deposits of the CDC as on date of Amalgamation, if any, shall be transferred to CSIR.
4. Legal Cases pending with CDC (Both judicial and quasi-judicial) will be processed and contested by CSIR.
5. Various MoU/Contract to complete various projects / services with different parties / organization, signed by CDC, will be dealt by CSIR.
6. Banking Arrangements shall be as per convenience of CSIR.
7. Any residual issue that comes up later will be dealt by CSIR.
8. The routine matters pertaining to amalgamation including pay and allowances, etc of CDC employees will be transferred to CSIR, and decided by department in consultation with all concerned.
9. The premises currently occupied by CDC in India Habitat Centre (IHC) shall be vacated by the relocating employees & moveable assets in CSIR.
