**Sub:** Recovery of excess payment of transport allowance and DA thereon from all non-entitled officials of CSIR

महोदय / Sir.

I am directed to inform you that CSIR has issued instructions vide CSIR letter No. 5-1(3)/2008-PD dated 31.07.2017 regarding recovery of excess payment of Transport Allowance from non-entitled officers in line with Hon'ble Supreme Court directions in the case of State of Punjab and Ors Vs Rafiq Masih (White Washer) dated 18.12.2014. In the said order, the Hon'ble Supreme Court had stipulated certain conditions, wherein recoveries by the employers would be impermissible in law. However, in such situations, the waiver of recovery can be allowed with the express approval of Department of Expenditure in terms of DoPT OM No. 18/26/2011-Estt(Pay-I) dated 06.02.2014.

For other officers, who were paid Transport Allowance in excess of their entitlement, excess payment should be recovered without fail as per CSIR letter dated 31.07.2017.

It is, therefore, requested kindly to send us a list of officials from whom such excess payment of transport allowance cannot be recovered as per the directives of the Supreme Court in White Washer's case. The list may be sent as per the Proforma annexed herewith, both through email (manpower@csir.res.in) in excel format as well as through a duly signed hard copy latest by 2004.2018.

महोदय/Sir,

Kind attention is invited to the Ministry of Finance OM No. 21/(2)/2008-E.II(B) dated 29.08.2008 regarding grant of Transport Allowance which was endorsed in CSIR vide CSIR letter No. 5-1(3)/2008-PD dated 4th October, 2008.

Para 3 of the said OM provided that 'Officers drawing grade pay of Rs. 10,000/- and Rs. 12,000/and those in the HAG+ scale, who are entitled to the use of official car in terms of OM No. 20(5)-E.II(A)/93 dated 28.01.1994 shall be given the option to avail themselves of the existing facility or to draw the Transport Allowance at the rate of Rs. 7,000/- p.m. plus dearness allowance thereon'. This was further reiterated in Para 4 of CSIR letter No. 5-1(3)/2008-PD dated 21<sup>st</sup> November, 2008 while notifying the implementation of recommendations of 6<sup>th</sup> CPC in the case of Group IV Scientists.

However, Transport Allowance @ Rs 7000/- per month plus DA thereon was made to Scientists who were not entitled for it in terms of Ministry of Finance OM dated 28.01.1994 resulting in excess payment to such non entitled officials. This was also pointed out by the office of the Principal Director of Audit, Scientific Department during its visit to various CSIR Labs./Instts.

CSIR vide letter of even number dated 25 04 2014 also clarified that only the officers in PB-4 with Grade Pay of Rs. 10,000/- who are entitled to the use of official car in terms of Department of Expenditure OM No. 20(5)/E.II(A)/93 dated 28 01.1994 shall have the option to avail themselves of the existing facility or draw the transport Allowance @ Rs. 7,000/- per month plus DA thereon.

The Hon'ble Central Administrative Tribunal (CAT), Principal Bench, New Delhi vide order dated 13th May 2014 in the OA No. 4062/2013 clarified that recovery of transport allowance paid in excess is valid in law. The position has further been reiterated more recently in the judgement dated 24.08.2016 of OA No. 310/01059/2014.

On consideration of audit observations, DoPT and MoF instructions relating to the matter of excess payments made towards Transport Allowance @ Rs. 7000/- per month plus DA thereon to the non-entitled CSIR officials, it has been decided, with the approval of the competent authority, that necessary action may be taken for making recovery of such excess payments in line with the judgement of the Apex Court in the case of State of Punjab and Ors Vs Rafiq Masih (White Washer) dated 18.12.2014 (2015 AIR SCW 501) after issuance of show cause notice
