Respected Secretary Sir,

You are kindly aware that Probity issues are reviewed directly by the Cabinet Secretary. To facilitate the review, relevant information is required to be updated by all the Ministries/Departments by 15th day of every month on the Probity Portal [<https://probity-dopt.nic.in>].

2. For effectiveness of the review, recently a new proforma had been devised and placed on the Probity Portal to provide the information related to the personnel in whose cases the provisions of FR 56(j)/similar rules have been invoked. An email dated 05.08.2019 was sent to all the Ministries/Departments with a request to provide the requisite information by 16.08.2019. This was further followed up vide OM dated 16th August, 2019 as reminder. However the requisite information remains to be updated by your Ministry/Department.

3. On a review of the matter recently at the Prime Minister's Office, it was decided that a quick uploading of the current information and regular periodic updating of the same by all stakeholder departments has to be ensured. It had also been desired to complete the work within the following time frame –

- (i) Updation of reviews completed till date : **By 31st August**
- (ii) Updation of review cases currently under consideration by Ministry or Department and population of all field on the portal : **By 30th September**
- (iii) Monthly updation of data by Ministries / Departments : **By 10th of every month starting October 2019**

4. A meeting at the level of Secretary (Personnel) will be held shortly, the notice for which will be issued separately.

5. I would be grateful if you could kindly monitor at your level the achievements vis-à-vis the time frame mentioned herein above, with the Nodal Officer [CVO(s) concerned] to ensure that the requisite information pertaining to your Ministry/Department/other Organisation(s) is updated on Probity Portal timely.
