**Sub: Allocation of posts of Scientific & Technical staff of Group-IV and Group-III amongst Units/Divisions/Directorates of CSIR Hqrs.-reg.**


Revised sanctioned strength of Group –IV Scientists of CSIR Hqrs. was notified vide this office OM No. 17/68/Manpower/2014-HR-III (Admn.) dated 31<sup>st</sup> October, 2014 and the sanctioned strength of Group-III of CSIR HQ was intimated by Policy Division vide its note dated 22<sup>nd</sup> August 2017.

Keeping in view the reorganization of scientific and technical Divisions/ Directorates in CSIR Hqrs, a committee was constituted to work out the distribution of sanctioned strength amongst the existing Directorates/Divisions/Units of CSIR Hqrs by taking into consideration manpower requests, existing staff strength and work load of respective Directorates/Divisions/Units. Based on the recommendations of the committee, DG, CSIR has approved the allocation of sanctioned strength of Group-IV and Group-III amongst units/divisions/directorates of CSIR Hqrs. as follows:
