OFFICE MEMORANDUM

Sub : Transfer & Posting of Common Cadre Officers - reg.

Ref : CSIR OM of even number dated 30.03.2021 and 16.04.2021

Transfer and Posting of CCOs was notified vide CSIR OM of even number dated 30.03.2021. However, keeping in view the upsurge of COVID-19 cases and likely difficulties in movement of staff members, any further implementation of aforesaid OM dated 30.03.2021 was put on hold vide CSIR OM of even number dated 16.04.2021.

2. Meanwhile a number of representations were received from CCOs seeking retention at the same place of posting or posting to a place of choice as well as some requests from Directors/Heads.

3. All such requests have been considered by the Transfer and Posting Committee (TPC) keeping in view present functional needs of CSIR and public interest.
