**Sub: Amendment to the "Public Procurement (Preference to Make in India) Order, 2017" - Empowerment of Directors of CSIR Labs/Instts. and HoDs of Units under CSIR Hqrs. to grant Exemption on case to case basis**

Sir/Madam,

The Govt. of India has amended "Public Procurement (Preference to Make in India) order, 2017 (PPP-MII) vide DPIIT communication No. P-45021/2/2017-P.P.(BE-II) dated 13<sup>th</sup> May, 2021 (copy enclosed). A new Para (# 21) has now been added which allows for relaxation from the application of PPP-MII order to the procurements for containment of COVID-19 global pandemic. This exemption is, however, applicable only till **30.09.2021**.

In pursuance of the said order, Secretary, DSIR/DGCSIR has been pleased to assign the power to grant exemptions, on case to case basis, to the Directors of the CSIR Labs/Instts. and the HoDs of the Units of CSIR Hqrs. which have been made independent procuring entities.

**ORDER**

**Sub: Amendment in the "Public Procurement (Preference to Make in India) Order, 2017" – reg.**

The "Public Procurement (Preference to Make in India) Order, 2017" (PPP MII Order) dated 15<sup>th</sup> June, 2017 issued pursuant to Rule 153 (iii) of the General Financial Rules 2017 and further revised vide Order dated 28<sup>th</sup> May, 2018, 29<sup>th</sup> May, 2019, 04<sup>th</sup> June, 2020 and 16<sup>th</sup> Sep, 2020 stands amended to the following extent with immediate effect:

a) A new Para 21 may be inserted in the Order as under:

**"Para 21:**

Notwithstanding any provision stated above, the administrative Department undertaking the procurement (including procurement by any entity under its administrative control) may exempt the procurement of supplies required for containment of COVID-19 global pandemic from the applicability of this Order/ any provision thereof, after written approval of Secretary of the Department concerned or any other Authority having been assigned power by the Secretary of the Department concerned. The aforesaid exemption shall be applicable only till 30.09.2021.
