**Sub: CSIR-CLRI, Chennai project on Indian National Footwear Sizing System  
– regarding foot survey**

CSIR-CLRI, Chennai is leading a project of DPIIT, Ministry of Commerce and Industry on developing an 'Indian National Footwear Sizing System' to help our country in producing comfortable footwear for our population. In order to achieve this purpose, CLRI, with its synergy partners, is conducting a 'Anthropometric Foot Measuring Survey' across India to capture the foot dimensions of various age and gender groups. As a part of this foot measuring survey, CLRI has proposed to carry out a small survey in CSIR Hqrs. premises.

In the aforesaid background, the **Team CLRI and their synergy partner (CFTI, Agra) have been allowed to hold the above survey in CSIR Hqrs. on 04/02/2022.** As a part of the survey, the Team CLRI will measure and capture foot dimensions with 3D Foot Scanner in CSIR Hqrs. Auditorium (Shanti Swaroop Bhatnagar Sabhagar) from 9.30 AM onwards till such time the maximum foot dimensions are captured. The Officers/Staff Members are requested to volunteer themselves for foot scanning so that the purpose of the survey is achieved/served.

Further, while making themselves available for foot scanning, all are also requested to observe covid protocols of maintaining social distancing and wearing of face masks etc.
