Sub Details of Vacancies and Eligibility Lists etc. for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2021 - reg.


The meetings of DPCs for consideration for Promotion to Group 'A' Common Cadre Posts for the Vacancy Year 2020 are **scheduled to be convened very shortly**. In order to have transparency in the process, the following details are notified herewith for information of all concerned:-

1. DG, CSIR has been pleased to grant relaxation, as per Recruitment Rules, in Qualifying Service for the posts wherever the available candidates are less than the number of vacancies. Thus relaxation in Qualifying Service has been granted for promotion to the posts of (i) Sr. DS/Sr. COA, (ii) DS/COA, (iii) Sr. Dy. FA/Sr. COFA, (iv) F&AO, (v) PSO, (vi) Sr. PPS and (vii) PPS.
2. Details of vacancies of all the posts of all the 04 Cadres. The exact number of vacancies depend upon various factors and, therefore, may vary at the time of holding of DPC.
3. The ZOCs for the posts of DS/COA and US/AO; Dy. FA/COFA and F&AO, COSP and SPO and PPS are dependent, inter alia, upon the resultant vacancies. It is presumed that all the vacancies in the higher posts will be filled up and all the resultant vacancies will be available on or before 31.12.2021. If this does not happen, the total vacancies and consequently ZOCs will get reduced and some of the junior officers notified in the instant eligibility lists may not come in the consecutive revised ZOCs.
4. Eligibility Lists and ZOCs have been prepared in accordance with the guidelines contained in DOPT OM Nos. 22011/1/90-Estt(D) dated 12.10.1990 & 22.04.1992.
5. The promotion panels will be subject to the outcome of OAs pending before different benches of the Hon'ble CAT. Further, panels for the posts of US/AO, F&AO, SPO and PPS will be subject to further orders of Hon'ble Supreme Court in various cases mentioned in DOPT OM No. 36012/11/2016-Estt. (Res-I) {Pt-II} dated 27.06.2018 and/or in any other case related with the matter of reservation in promotion.
6. Officers included in the eligibility lists are advised to ensure that their O-APAR folders upto 31.03.2019 are complete in all respects.
7. The Interviews will be held through Online Mode only.


