Sub: Result of Screening process for recruitment of Technical Assistant in CSIR Hq.

Ref: Advertisement No. R&A/01/2022 (Last date of receipt of applications-17th January, 2023) for 34 posts of Technical Assistant.

NOTIFICATION

Kind attention of all the candidates is invited, who applied for the position(s) of Technical Assistants under different Post Codes 220101 to 220111 against CSIR Advertisement No. R&A/01/2022.

As per the stipulations of the advertisement, the eligible candidates were required to submit online applications through CSIR official website by 17.01.2023 (5:00 PM). The candidature of only those applicants whose online applications are received within the stipulated time including fee payment (If applicable) and uploaded SBI e-Receipt in the online application (If applicable), before the last date for Submission of Online application is to be considered by the CSIR and others to be rejected.

Duly constituted Screening Committees, under the provisions of "CSIR Service Rules, 1994, for Recruitment of Scientific, Technical and Support Staff", scrutinized all the online applications in detail, including the supporting documents, according to the stipulations mentioned in the advertisement and fixed the following criteria for all the postcodes to shortlist candidates to be called for Trade Test.

Criteria of the Screening Committee:

Essential Qualification as per Advertisement.

Based on the recommendations of the Screening Committees, the list of candidates provisionally shortlisted to appear for Trade Test and the list of candidates not recommended by the Screening Committee along with the reasons against each post codes are listed in **Annexure-I to Annexure-XI**. The codes for rejection are listed in **Annexure-A**.

Further, the screening of the candidates has been done prima facie on the basis of information furnished in the online application and with the supporting

uploaded documents submitted by the candidates as per the requirement of the advertisement.

The shortlisting of candidates to the aforementioned post for the Trade Test is **Provisional** and is subject to verification of all relevant original documents and production of original certificates as and when required by the office. If at any stage of the recruitment process, if it is found that the applicant has furnished any incorrect/false information/certificate/documents or has suppressed any material fact(s) or does not fulfil any of the conditions of eligibility such as essential qualification, prescribed age limit, category etc., for the posts notified vide CSIR Advt. No. R&A/01/2022, the candidature will be liable to be cancelled without any further notice. If any of these shortcoming(s) is/are detected after appointment in CSIR, his/her services are liable to be summarily terminated. Candidates are, therefore, advised to check carefully and satisfy themselves that they fulfill all conditions as stipulated in the advertisement for the post they have applied for.

While every care has been taken in preparing the results of screening process, however, CSIR reserves the right to rectify inadvertent error or typographical /printing mistakes, if any, at any stage.

Representations, if any, of the candidates can be submitted only through the Recruitment Portal <u>https://recruitment.csir.res.in</u> duly enclosing proof in support of his/her claim on or before 21.07.2023 (till 17:00 hours). The representation(s) received after stipulated period will not be entertained. Representation(s) submitted by email, telephone and other means will not be acceptable.

The decision of the Competent Authority, CSIR on such representations will be final and binding in this regard.

It may be noted that representations, if any, can be submitted through the above portal with the Login credentials received on candidates registered email id/Mobile Number during the submission of online application for Technical Assistants against CSIR Advertisement No. R&A/01/2022. In case candidate is not able to access the portal, click on "Forgot Password" and follow the steps to retrieve lost User ID & Password.

Dates regarding the Trade Test shall be hosted on the website in due course and candidates may check the website for the updates. No interim or telephonic enquiry or correspondence will be entertained.
