Based on the Department of Personnel and Training, Government of India OM No. 39020/01/2013-Estt(B), dated 09.10.2015 (2) DoPT OM No. 39020/01/2013-Estt(B)-Part, dated 29.12.2015 and DoPT Order No. 21/12/2010-CS.I(P) dated 21.12.2015 and DoPT notification No. G.S.R. 601(E) dated 31.07.2015 and in supersession of CSIR letter No. 5-1(315)/2015-PD dated 08.04.2016, I am directed to state that the Governing Body, CSIR in its 188th meeting held on 22nd November, 2016 has approved the following amendments in CSIR Administrative Services [Recruitment & Promotion] Rules, 1982:
